CREDITORS OF AMRAPALI INDUSTRIES LIMITED CONVENED AS PER THE DIRECTIONS OF  
THE HON'BLE NATIONAL COMPANY LAW TRIBUNAL, AHMEDABAD BENCH**

**I.** This is a statement accompanying the Notice convening the meeting of the unsecured creditors of the Company, pursuant to the Order dated September 13, 2021 read with November 16, 2021 passed by the Hon'ble National Company Law Tribunal, Ahmedabad Bench ("Hon'ble Tribunal" or "NCLT") in the Company Application (CAA) No. 64 of 2021, referred to hereinabove, a Meeting of the unsecured creditors of Amrapali Industries Limited is being convened and held at the Registered Office, at Unit No. PO5-02D, 5th Floor Tower A WTC Gift City, Gandhinagar, Gujarat - 382355 on Monday, December 27, 2021 at 4:30 p.m. for the purpose of considering, and if thought fit, approving the arrangement embodied in the **Scheme of Arrangement in the nature of Demerger between Amrapali Industries Limited and Amrapali Asset Reconstruction Company Private Limited and their respective shareholders and creditors.** ("Scheme").

**II. DETAILS AS PER RULE 6(3) OF THE ARRANGEMENT RULES**

**Venue, Time and Date of Meeting :**

The National Company Law Tribunal, Ahmedabad Bench vide its Order dated September 13, 2021 read with November 16, 2021, filed by Amrapali Industries Limited and Amrapali Asset Reconstruction Company Private Limited under Sections 230 to 232 of the Companies Act, 2013, has directed the calling, convening and conducting of the Meeting of the unsecured creditors of Amrapali Industries Limited on Monday, December 27, 2021 at 04:30p.m at Unit No. PO5-02D, 5th Floor Tower A WTC Gift City, Gandhinagar, Gujarat - 382355.

**III.** A copy of the Scheme is enclosed herewith as **Annexure A**. The proposed Scheme is envisaged to be effective from the Appointed Date. The Appointed Date is as defined in the Scheme. The Scheme shall be operative from the Effective Date.

IV. It is submitted that the Applicant Demerged Company has two different divisions namely trading of Commodities and Shares and entertainment business. With a view to achieving operational efficiencies and streamlining its current structure, The Applicant Demerged Company has decided to demerge its Entertainment Division into the Applicant Resulting Company with primary intention to focus its business synergies on Share and Commodities trading. It is submitted that the transfer and vesting of the Entertainment Division of the Applicant Demerged Company to the Applicant Resulting Company pursuant to this Scheme is with a view to establishing highest operational standards and to unlock the economic value of the Entertainment Division.

V. The draft Scheme was placed before the Audit Committee and Board of Directors of the Demerged Company at their respective meetings held on February 24, 2020. In accordance with the provisions of SEBI Circular No. CFD/DIL3/CIR/2017/21 dated March 10, 2017, the Audit Committee of the Demerged Company vide a resolution passed on 24<sup>th</sup> February, 2020 recommended the Scheme to the Board of the Directors inter-alia taking into account:

- (i) Valuation Report issued by Mr. Amrish Gandhi, Chartered Accountant (Registered Valuers),
- (ii) Fairness Opinion issued by Guinness Capital Advisors Services Limited, a Category I Merchant Banker and
- (iii) Certificate issued by M/s. Doshi Maru and Associates, Chartered Accountants, Statutory Auditors of the Demerged Company in relation to the accounting treatment prescribed in the Scheme.

Copy of the Valuation Report and Fairness Opinion is enclosed to this Notice as "**Annexure B**" and "**Annexure C**".

VI. Based upon the recommendation of the Audit Committee, the Board of Directors of the Demerged Company approved the Scheme subject to the approval of the shareholders and creditors, NCLT and such other governmental/statutory authorities as advised by NCLT.

VII. In accordance with the provisions of Sections 230-232 of the Act, the Scheme shall be acted upon only if a majority of the unsecured creditors, of the Applicant Company, are in favor of the resolution for the approval of the Scheme are more than the number of votes casted against it.

#### **VIII. BACKGROUND OF THE COMPANIES INVOLVED IN THE SCHEME IS AS UNDER:**

##### **1. AMRAPALI INDUSTRIES LIMITED ('THE DEMERGED COMPANY' OR 'AIL' OR 'THE COMPANY')**

- a) Amrapali Industries Limited (hereinafter referred to as the "the Applicant Demerged Company" or "the Demerged Company" or "AIL") is a Listed Public Company (BSE Limited – Main Board) having its CIN: L91110GJ1988PLC010674. The Applicant Demerged Company was originally incorporated as Amrapali Synthetics Private Limited under the Companies Act, 1956 vide certificate of incorporation dated May 10, 1988 issued by the Registrar of Companies, Gujarat, Dadra & Nagar Haveli. The Company was converted into a public limited company and the name was changed to Amrapali Synthetics Limited vide Fresh certificate of incorporation dated March 4, 1992. Later, the name of the Company was changed to Amrapali Industries Limited vide certificate of incorporation dated April 8, 1992. The Applicant Demerged Company got listed with BSE Limited on February 08, 1994. The Permanent Account Number of the Demerged Company is AABCA8337J. The company is engaged in the business of trading of Commodities and Shares and entertainment business.

  - To manufacture, produce, buy. Sell, distribute, import, export, deal in all kinds of laminated sheets, fibrewood sheets and their products and bye-products
  - To do the business of commodity (including commodity derivatives) broking, trading, and hedging
  - To carry on business as brokers and traders in all commodities and commodity derivatives, and to act as market makers, finance brokers, sub brokers, underwriters, sub underwriters, providers of service for commodity related activities
  - To buy, sell, take hold deal in, convert, modify, add value, transfer or otherwise Dispose of commodities and commodity derivatives, and to carry on the above business in India and abroad for and on behalf of the company as well as for others.
  - To apply for and obtain registration as Commodities Broker or Member of any Commodities Exchange anywhere in India and abroad.
  - To do the business of commodity warehousing, processing and consumption

The Company is engaged in the business to carry on the business of securitization and/or asset reconstruction and for that purpose to acquire or deal with or dispose off any of assets. The Object no 15 of the (c) Other objects of the Company as per Memorandum of Association allow company to carry on the entertainment business.
- b) The Registered Office of the Resulting Company is situated at 19/20/21 3rd Floor, Narayan Chambers, Ashram Road, Ahmedabad, Gujarat - 380009 and Email Id : ail@amrapali.com
- c) The authorized, issued, subscribed and paid-up share capital of the Resulting Company as on 31<sup>st</sup> March 2021 is as under:

- d) The objects for which the Resulting Company has been established are set out in its Memorandum of Association. The main objects of the Resulting Company are set out hereunder:
1. To act as a Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and carry on the business of securitization and / or asset reconstruction and for that purpose to acquire and / or deal with and / or dispose off any and all assets, partly or wholly including but not limited to financial assets, property, secured assets, of any nature and otherwise to assist or participate in the securitization, realization or restructuring or reconstruction of financial assets and / or secured assets and for such purpose to mobilize funds in any manner including but not limited to issue of debentures or bonds or other securities and to offer or otherwise issue or deal in security receipts of any nature and tenor to Qualified Institutional Buyers or any other persons, natural or juristic (as may be permitted under the SRFAESI from time to time) and for the purpose aforesaid or in connection with asset reconstruction or securitization, to act as trustees, managers, administrators, receivers, valuers or otherwise and to engage, appoint, discharge any intermediaries or agents or professional or consultants.
  2. To act as trustees for various trusts set up pursuant to any scheme in accordance with the SRFAESI and for that purpose to set up, promote, little, approve and execute trust/s and devise various schemes for raising funds in any manner from Qualified Institutional Buyers or any other persons, natural or juristic (as may be permitted under the SRFAESI form time to time) and / or to float various schemes and to issue Security Receipts and to deploy funds raised and to undertake securitization and reconstruction transactions, including enforcement of security interest and receive fees for services and to hold the property in trust for the benefit of the beneficiaries of the trust, to undertake and carry on the functions

and duties of trustee and to undertake and execute trusts of all kinds, whether public or private, including declaring the company itself as a trustee and to act in furtherance of any trust directions, discretion or other obligation or permission and generally to carry on the trustee business and in particular and without limiting the generality of the above, to act as trustees.

3. To carry on the business of asset reconstruction; acquisition and / or securitization of any or all financial assets, property or secured assets, of any nature, either wholly or partly, to take over of management, sale, lease of the business, secured assets, financial assets, property, rescheduling of debts, creation of security interest, enforcement of security interest, settlement of due and / or taking possession of secured assets, to run, operate and maintain any such secured assets and to distribute the proceeds thereof whether periodically or otherwise, to maintain books of account, to formulate policies on all the above matters, including but not limited to, valuation of assets under each scheme formulated by each trust and declaration of Net Asset Value of Security Receipts, whether in its capacity as a trustee or otherwise.
- e) The object of the Company is to carry on the business of securitization and/or asset reconstruction and for that purpose to acquire or deal with or dispose off any of assets. The Clause 15(c) of the Other objects of the Company as per Memorandum of Association allow company to carry on the entertainment business.

There has been no change in the object clause of the Demerged Company during the last five (5) years.

## **IX. RATIONALE OF THE SCHEME:**

The Applicant Demerged Company has two different divisions namely trading of Commodities and Shares and entertainment business. With a view to achieving operational efficiencies and streamlining its current structure, AIL has decided to demerge its Entertainment Division into AARCPL with primary intention to focus its business synergies on Share and Commodities trading. The transfer and vesting of the Entertainment Division of AIL to AARCPL pursuant to the Scheme is with a view to establishing highest operational standards and to unlock the economic value of the Entertainment Division.

The re-organization exercise would inter alia achieve the following advantages:

- a) Realigning assets to create an integrated business model.
- b) More focused leadership and dedicated management
- c) Greater visibility on the performance of Share and Commodities trading.

Accordingly, the Board of Directors of the Demerged Company and the Resulting Company have formulated the Scheme for the transfer the Entertainment Division of the Demerged Company into the Resulting Company, pursuant to the provisions of Sections 230-232 and other relevant provisions of the Companies Act, 2013 (including any statutory modification or reenactment or amendment thereof).

## **X. SALIENT FEATURES GIVEN HEREUNDER FOR AS PART OF THE SCHEME:**

- (i) The Scheme is presented under Sections 230-232 and other applicable provisions of the Companies Act, 2013, as may be applicable, the transfer the Entertainment Division of the Demerged Company into the Resulting Company;
- (ii) The Demerged Company and the Resulting Company shall make application(s) and/or petition(s) under Sections 230-232 of the Companies Act, 2013 and other applicable provisions of the Companies Act, 2013 to the jurisdictional NCLT, as the case may be for sanction of this Scheme and all matters ancillary or incidental thereto and complied by the respective companies;
- (iii) „Appointed Date“ means 1<sup>st</sup> April 2021;
- (iv) „Effective Date“ means the date last or the last dates on which the Certified copy of the orders of the Tribunal, under Section 232 of the Companies Act, 2013 sanctioning this Scheme is filed by the respective Companies with the Registrar of Companies.

## **THE OTHER SALIENT FEATURES OF THE SCHEME AS FILED WITH NCLT AHMEDABAD BENCH AND AS PER THE RESPECTIVE CLAUSE OF THE SCHEME, ARE AS UNDER:**

### **5. CONSIDERATION**

*5.1. Upon this Scheme becoming effective and upon vesting of the Entertainment Business of Demerged Company in Resulting Company in terms of this Scheme, Resulting company shall without any further application or deed, issue and allot equity shares, credited as fully paid-up, to the extent indicated below, to the equity shareholders of Demerged company and whose names appear in the Register of Members of Demerged Company on the Effective Date or to such of their respective heirs, executors, administrators or other legal representative or other successors in title as may be recognized by the Board of Directors of Resulting Company in the following manner:*

*"1 (One) fully paid up Equity Share of Rs. 10/- each of Resulting Company shall be issued and allotted for every 15 (Fifteen) fully paid up Equity Shares of Rs. 5/- each held in Demerged Company."*

*5.2. Any fraction shares arising on issue of Equity Shares as above will be rounded off to the nearest integer.*

*5.3. Mr. Amrish Gandhi, Registered Valuer, Regn. No. IBBI/RV/03/2019/12508, has issued the report on the aforementioned share entitlement ratio. M/s Guinness Corporate Advisors Private Limited., Category-I, Merchant Banker, has provided its fairness opinion on the aforesaid share entitlement ratio. The aforesaid share entitlement ratio and fairness opinion have been duly considered by the Board of the Demerged Company and the Resulting Company;*

*5.4. The New Equity Shares shall be issued and allotted in dematerialized form to the equity shareholders of Demerged Company. If the Resulting Company has received notice from any member that New Equity Shares are to be issued in physical form or if any member has not provided any requisites details relating to his account with a depository participant or other confirmation as may be required or if the details furnished by any member do not permit electronic credit of New Equity Shares, then the Resulting Company shall issue New Equity Shares in physical form to such member or members.*

- 5.5. *The New Equity Shares to be issued and allotted as above shall be subject to the Memorandum and Articles of Association of Resulting Company and shall rank pari passu with the existing equity shares of resulting Company in all respects including dividends, voting rights and for all other benefits and in all other respects.*
- 5.6. *The Resulting Company shall apply for listing of its equity shares including those issued in terms of Clause 5.1 on Stock Exchanges immediately after receipt of the order of Tribunal as per applicable provisions of SEBI Circulars. The Resulting Company shall ensure that steps for listing of equity shares issued in terms of Clause 5.1 of this Scheme are completed and trading in such equity shares commences within sixty days of receipt of the order of the Tribunal, simultaneously on all the Stock Exchanges;*
- 5.7. *The equity shares allotted pursuant to the Scheme shall remain frozen in the depository system till listing/trading permission is given by the designated stock exchange;*
- 5.8. *There will be no change in the shareholding pattern of Amrapali Assets Reconstruction Company Private Limited between the record date and the listing Approval.*
- 5.9. *The Board of Directors of Resulting Company shall, if and to the extent required, apply for and obtain any approvals from concerned Government/ Regulatory authorities for the issue and allotment of New Equity Share.*
- 5.10. *In the event of there being any pending share transfers with respect to the application lodged for transfer by any shareholder of Demerged Company, the Board of Directors, or failing which the Board of Director of Resulting Company shall be empowered in appropriate case, even subsequent to the Record Date to effectuate such a transfer in Demerged Company as if such changes in registered holder were operative as on the Record Date, in order to remove any difficulties arising to the transferor or the transferee of the share(s) in Demerged Company and in relation to the Demerged Company Equity Shares after the Schemes becomes effective.*
- 5.11. *New Equity Shares to be issued and allotted by Resulting Company to the equity shareholders of Demerged Company pursuant to Clause 5.1 of this Scheme, in respect of any equity shares in Demerged Company which are held in abeyance under the provisions of Section 126 of the Act, pending allotment or settlement of dispute, by order of court or otherwise, be held in abeyance by Resulting Company.*
- 5.12. *Approval of this Scheme by the equity shareholders of Resulting Company shall be deemed to be due compliance of the provisions of Section 61 of the Act and the other relevant and applicable provisions of the Act for the issue and allotment of New Equity Shares by Resulting Company, as provided in this Scheme.*
- 5.13. *The approval of this Scheme by the equity shareholders of Resulting Company under Sections 230 to 232 of the Act shall be deemed to have the approval under Sections 13, 14 and 62 of Companies Act, 2013 and any other applicable provisions of the Act and any other consents and approvals required in this regard.*

## **6. Accounting Treatment:**

6.1. *The Demerged Company and Resulting Company shall account for the Scheme in their respective books/financial statements in accordance with applicable Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015, as amended from time to time including as provided herein below:*

**6.2. In the books of the Demerged Company :**

a) *All the assets, liabilities and reserves pertaining to the Demerged Undertaking, which cease to be the assets, liabilities and reserves of the Demerged Company, will be reduced from the books of accounts of the Demerged Company at their respective book values, as appearing immediately before the Appointed Date.*

*The difference if any, between the value of assets of the Demerged Undertaking and the aggregate of the book values of the liabilities and reserves of the Demerged Undertaking, shall be transferred to the Capital Reserve Account.*

**6.3. In the books of the Resulting Company:**

a) *The Resulting Company shall record the assets, liabilities and reserves pertaining to the Demerged Undertaking vested in it pursuant to this Scheme, at the respective book values as appearing in the books of the Demerged Company, immediately before the Appointed Date.*

b) *The Resulting Company shall credit to the Share Capital Account, in the books of accounts, the aggregate face value of the new equity shares issued by it to the shareholders of the Demerged Company.*

c) *The difference if any, between the value of assets of the Demerged Undertaking (as recorded pursuant to (a) above) and the aggregate of the book values of the liabilities and reserves of the Demerged Undertaking, the amount credited to the share capital account pursuant to Clause 5 above, after taking into effect the amount of share capital as reduced shall be transferred to the Capital Reserve Account in the books of the Resulting Company. The shortfall, if any, shall be debited to Goodwill account of Resulting Company.*

d) *If considered appropriate for the purpose of application of uniform accounting policies and method or for compliance with the applicable accounting standards, the Resulting Company may make suitable adjustment to the accounting treatment and adjust the effect thereof in the manner determined by the Board of the Resulting Company.*

**7. TAXATION MATTERS**

7.1. *Upon the Scheme becoming effective and with effect from the Appointed Date, all the taxes, duties, cess paid or payable by the Demerged Company (including under the Income Tax Act, 1961 or any other applicable laws) pertaining to the Entertainment Business including but not limited to IGST, CGST, SGST, GST, advance taxes, tax deducted at source, withholding tax, credits, refunds, claims or interest thereon, if any, shall for all purpose, be treated as IGST, CGST, SGST, GST, advance taxes, tax deducted at sources, withholding tax, credit, refunds, claims or interest of the Resulting Company.*

7.2. *Upon the Scheme becoming effective and with effect from the Appointed Date, the Resulting Company is expressly, permitted to revise and file returns pertaining to the Entertainment Business*

*belonging to Demerged Company, including but not limited to income tax returns, tax deducted at source return, sale tax/ value added tax returns, excise return, service tax returns, IGST, CGST, SGST, GST return and other tax returns filed with the governmental and other authorities.*

7.3. *All expenses incurred by the Demerged Company under Section 43B of the Income Tax Act, 1961, in relation and pertaining to the Entertainment Business shall be claimed as a deduction by the Resulting Company and the transfer of the Demerged Undertaking shall be considered as succession of business by the Resulting Company.*

7.4. *All the expenses incurred by the Demerged Company and the Resulting Company in relation to the Scheme, including stamp duty expenses, if any, shall be allowed as deduction to each of the Demerged Company and the Resulting Company in accordance with Section 35DD of the Income Tax Act, 1961.*

## **8. PROFIT, DIVIDEND, BONUS/RIGHT SHARES**

*Demerged Company shall not utilize profits or income, if any, of the Entertainment Business for any purpose including declaring or paying any dividend in respect of the period falling on and after the Appointed Date. Demerged Company shall also not utilize profits, adjust or claim adjustment of the profits/loss as the case may be earned/ incurred or suffered in respect of the Entertainment Business after the Appointed Date.*

*Until the Effective Date, Demerged Company shall not issue or allot any further equity share either by way of right issue or bonus issue or otherwise.*

## **9. CONDUCT OF BUSINESS UNTIL THE EFFECTIVE DATE**

*With effect from the Appointed Date and upto and including the Effective Date:*

9.1. *Demerged Company shall be deemed to have been carrying on and shall carry on its business and activities relating to Entertainment Business and shall be deemed to have been held and stood possessed of and shall hold and stand possessed of all its properties and assets pertaining to the Entertainment Business for and on account of and in trust for Resulting Company. Demerged Company hereby undertakes to hold its said assets with utmost prudence until the Effective Date.*

9.2. *Demerged Company shall carry on its business and activities relating to Entertainment Business with reasonable diligence, business prudence and shall not, except in the ordinary course of business or without prior written consent of Resulting Company, alienate charge, mortgage, encumber or otherwise deal with or dispose of Entertainment Business or part thereof.*

9.3. *All the profits or income accruing or arising to Demerged Company or expenditure or losses arising or incurred or suffered by Demerged Company pertaining to the Entertainment Business shall for all purposes be treated and be deemed to be accrued as the income or profits or losses or expenditure as the case may be of Resulting Company.*

9.4. *Demerged Company shall not vary the terms and conditions of employment of any of the employees of Entertainment Business except in the ordinary course of business or without the prior consent of Resulting Company or pursuant to any pre-existing obligation undertaken by Demerged Company, as the case may be, prior to the Effective Date;*

9.5. *All loans raised and all liabilities and obligations incurred by the Demerged Company with respect to the Entertainment Business after the Appointed Date and prior to the Effective Date, shall subject to the terms of this Scheme, be deemed to have been raised, used or incurred for and on behalf of the Resulting Company and to the extent they are outstanding on the effective Date, shall also, without any further act or deed be and be deemed to become the debts, liabilities, duties and obligations of the resulting Company;*

9.6. *Demerged Company shall be entitled, pending the sanction of the Scheme, to apply to the Central/State Government, and all other agencies, departments and authorities concerned as are necessary under any law or rules, for such consents, approvals and sanctions, which Resulting Company may require pursuant to this Scheme.*

## **10. EMPLOYEES**

10.1. *On the Scheme becoming operative, all staff and employees on the rolls of Demerged Company engaged in the Entertainment Business and who are duly identified or specified as such by the Board of Directors as at the Effective Date shall be deemed to have become staff and employees of Resulting Company without any break in their service and on the basis of continuity of service, and the terms and conditions of their employment with Resulting Company shall not be less favorable than those applicable to them with reference to their employment in Demerged Company.*

10.2. *It is expressly provided that, on the Scheme becoming effective, the Provident Fund, Gratuity Fund, superannuation Fund or any other Special Fund or Trusts, if any, created or existing for the benefit of the staff and employee of Entertainment Business or all purposes whatsoever in relation to the administration or operation of such Fund or Fund or in relation to the obligation to make contributions to the said Fund or Funds in accordance with the provisions thereof as per the terms provided in the respective Trust Deeds, if any, to the end and intent that all rights, duties, powers and obligations of Demerged Company in relation to Entertainment Business in relation to such Fund or Funds shall become those of Resulting Company. It is clarified that the services of the staff and employees of Entertainment Business will be treated as having been continuous for the purpose of the said Fund or Funds.*

## **11. LEGAL PROCEEDINGS**

11.1. *If any suit, appeal or other proceeding of whatever nature by or against Entertainment Business is pending, the same shall not abate or be discontinued or in any way be prejudicially affected by reason of or by anything contained in this Scheme, but the said suit, appeal or other legal proceedings may be continued, prosecuted and enforced by or against Resulting Company, as the case may be, in the same manner and to the same extent as it would or might have been continued, prosecuted and enforced by or against the Entertainment Business as if this Scheme had not been made.*

11.2. *In case of any ligation, suits, recovery proceedings which are to be intimated or may be imitated against Entertainment Business, Resulting Company shall be made party thereto and any payment and expenses made thereto shall be the liability of Resulting Company.*

## **12. CONTRACTS, DEEDS, ETC.**



12.1. Notwithstanding anything to the contrary contained in the contract, deed, bond, agreement or any other instrument, but subject to the other provisions of this Scheme, all contracts, deeds, bonds, agreements and other instruments, if any, of whatsoever nature and subsisting or having effect on the Effective Date and relating to the Demerged Undertaking, shall continue in full force and effect against or in favour of Resulting Company and may be enforced effectively by or against Resulting Company as fully and effectually as if, instead of Demerged Company, Resulting Company had been a party thereto.

12.2. Resulting Company, at any time after the coming into effect of this Scheme in accordance with the provisions hereof, if so required, under any law or otherwise, enter into, or issue or execute deeds, writings, confirmations, novations, declarations, or other documents with, or in favour of any party to any contract or arrangement to which Demerged Company is a party or any writings as may be necessary to be executed in order to give formal effect to the above provisions. Resulting Company shall, be deemed to be authorised to execute any such writings on behalf of Demerged Company and to carry out or perform all such formalities or compliances required for the purposes referred to above on the part of Demerged Company.

### **13. SAVING OF CONCLUDED TRANSACTIONS**

*The transfer of assets, properties and liabilities above and the continuance of proceedings by or against Resulting Company above shall not affect any transaction or proceedings already concluded in Demerged Company, in relation to the Demerged Undertaking on or after the Appointed Date till the Effective Date, to the end and intent that Resulting Company accepts and adopts all acts, deeds and things done and executed by Demerged Company, in relation to the Demerged Undertaking in respect thereto as done and executed on their behalf of Resulting Company.*

## **PART III - GENERAL TERMS AND CONDITIONS**

### **14. APPLICATION TO THE COMPETENT AUTHORITY**

*The Demerged Company and Resulting Company shall make necessary applications before the NCLT, Ahmedabad Bench for the sanction of this Scheme of Arrangement under Sections 230 to 232 read with Sections 52 and 66 of the Act. Any further approval under the Act arising from the Scheme shall be deemed to have been granted, without any application, for any transaction among the Demerged Company and the Resulting Company and/ or its Directors.*

### **15. MODIFICATIONS/AMENDMENTS TO THE SCHEME**

15.1. *The Demerged Company (through its Board of Directors) and the Resulting Company (through its Board of Directors) may, in their full and absolute discretion, assent to any alterations or modifications in this Scheme which the Competent Authority may deem fit to approve or impose and may give such directions as they may consider necessary to settle any questions or difficulty that may arise under the Scheme or in regard to its implementation or in any matter connected therewith (including any question or difficulty arising in connection with any deceased or insolvent shareholder of the respective Company).*

15.2. *In the event that any conditions are imposed by the Competent Authority which the Demerged Company and/or the Resulting Company find unacceptable for any reason whatsoever then the Demerged Company and/or the Resulting Company shall be entitled to withdraw from the Scheme.*

## **16. CONDITIONALITY OF THE SCHEME:**

*This Scheme is and shall be conditional upon and subject to:*

- 16.1. The requisite consent, approval or permission from the Stock Exchanges and/or SEBI pursuant to Regulation 37 of the Listing Regulations read with SEBI Circulars and Regulation 11 and 94 of the Listing Regulations which by law or otherwise may be necessary for the implementation of this Scheme in compliance with the provisions of SEBI Circulars;*
- 16.2. The scheme is conditional upon scheme being approval by the PUBLIC shareholders through e-voting in terms of para 9 (a) of part I of Annexure I of SEBI circular No. CFD/DIL3/CIR/2017/21 dated March 10, 2017 and the scheme shall be acted upon only if vote cast by the public shareholders in favour of the proposal are more than the number of votes cast by the public shareholders against it.*
- 16.3. The approval of the Scheme by the respective requisite majorities in number and value of the shareholders and/or creditors (where applicable) of the Companies in accordance with Section 230 to 232 of the Act;*
- 16.4. The Scheme being sanctioned by the Tribunal in terms of Sections 230 to 232 and other relevant provisions of the Act and the requisite orders of the Tribunal; and*
- 16.5. Certified copies of the orders of the Tribunal sanctioning this Scheme being filed by the Companies with the Registrar of Companies as per the provisions of the Act.*

## **17. EFFECT OF NON-RECEIPT OF APPROVALS**

- 17.1. In the event of any of the approvals or conditions enumerated in the Scheme not being obtained or complied, or for any other reason, this Scheme cannot be implemented, then the Board of Directors of Demerged Company and Resulting Company shall mutually waive such conditions as they consider appropriate to give effect, as far as possible, to this Scheme and failing such mutual agreement the Scheme shall become null and void and each party shall bear and pay their respective costs, charges and expenses in connection with this Scheme*

## **18. EFFECTIVE DATE OF THE SCHEME:**

- 18.1. This Scheme shall become effective when all the following conditions are fulfilled:*
  - i. The Scheme being approved by the requisite majority of the shareholders and creditors of the Demerged Company and the Resulting Company as may be required under the Act and/or the orders of the Competent Authority.*
  - ii. The Scheme is sanctioned by the said Competent Authority under Section 230 to 232 of the Act.*
  - iii. The certified copy of the order of the said Competent Authority sanctioning the Scheme is filed with the Registrar of Companies, Ahmedabad.*

## **19. MISCELLANEOUS**

*In case any doubt or difference or issue arises between the Companies or any of their shareholders, creditors, employees or persons entitled to or claiming any right to any shares in any of the Companies, as to the construction of this Scheme or as to any account, valuation or apportionment to be taken or made in connection herewith or as to any other aspects contained in or relating to or arising out of this Scheme, the same shall be amicably settled among the Board of the respective Companies, and the decision arrived at therein shall be final and binding on all concerned parties.*

## **20. COST, CHARGES AND EXPENSES**

*20.1. Save and except as provided in the Scheme, the Demerged Company shall bear all costs and charges incurred in relation to filing of application, petition, affidavits etc. with the Hon'ble Tribunal, fees of legal counsels, consultants and professionals engaged by the Demerged Company in connection with the implementation of the Scheme and matters incidental thereto, any income tax liability in the hands of the Demerged Company pursuant to the Scheme.*

*20.2. Save and except as provided in the Scheme, the Resulting Company shall bear all costs incurred in relation to fees of legal counsels, consultants and professionals engaged by the Resulting Company, stamp duty payable on the order of Hon'ble Tribunal approving the Scheme, issue of shares to the shareholders of Demerged Company, stamp duty and registration charges on mutation of immovable properties belonging to the Demerged Undertaking, fee for increasing the authorized share capital of the Resulting Company and any income tax liability arising in the hands of Resulting Company in connection with the implementation of the Scheme and matters incidental thereto.*

**A. PREAMBLE**

This scheme of arrangement between Amrapali Industries Limited and Amrapali Asset Reconstruction Company Private Limited and their respective shareholders ("Scheme", more particularly defined hereinafter) for demerger is presented under the provisions of sections 230 to 232 and other relevant provisions of the Companies Act, 2013, as may be applicable, and also read with Section 2(19AA) and other relevant provision of Income Tax Act, 1961, as may be applicable, for Demerger of the Entertainment Business (more particularly defined hereinafter) of Amrapali Industries Limited and vesting of the same in Amrapali Asset Reconstruction Company Private Limited on a going concern basis.

**B. BACKGROUND AND DESCRIPTION OF THE COMPANIES**

- i. Amrapali Industries Limited (hereinafter referred to as "AIL" or the "Demerged Company") was originally incorporated as Amrapali Synthetics Private Limited under the Companies Act, 1956 vide certificate of incorporation dated May 10, 1988 issued by the Registrar of Companies, Gujarat, Dadra & Nagar Haveli. The Company was converted into a public limited company and the name was changed to Amrapali Synthetics Limited vide fresh certificate of incorporation dated March 4, 1992. Later on the name of the Company was changed to Amrapali Industries Limited vide certificate of incorporation dated April 8, 1992.

AIL got listed with BSE on February 08, 1994. Further the AIL filed petition with Gujarat High Court on November 25, 2008 in the matter of Scheme of Arrangement in the nature of Amalgamation of Amrapali Developers (India) Limited and Korrwett Capital Investments Private Limited with Amrapali Industries limited and High Court of Gujarat at Ahmedabad passed an order on August 26, 2009. Equity Shares of AIL was sub-divided into face value of Rs 5 each from face value Rs 10 each on January 28, 2011. The Corporate Identification Number of the Company is L91110GJ1988PLC010674. AIL is engaged in the business of trading of Commodities and Shares and entertainment business.

Amrapali Asset Reconstruction Company Private Limited (hereinafter referred to as "AARCPL" or the "Resulting Company") was incorporated as a private limited company under the provisions of the Companies Act, 1956 vide certificate of incorporation dated January 8, 2010 having its registered office at 19/20/21 3rd Floor, Narayan Chambers, Ashram Road, Ahmedabad - 380009. The Corporate Identification Number of the Company is U65190GJ2010PTC059157. The object of the Company is to carry on the business of securitization and/or asset reconstruction and for that purpose to acquire or deal with or dispose off any of assets. The Object no 15 of the (c) Other objects of the Company as per Memorandum of Association allow company to carry on the entertainment business.

- ii. Demerged Company and Resulting Company are part of the Amrapali Group. The Demerged company has the Entertainment Project at Kankaria Lake in the city of Ahmedabad, it is identity of Ahmedabad, tourist place since almost 500 years, it is second largest lake in Ahmadabad, Gujarat.

### C. RATIONALE AND PURPOSE OF THE SCHEME

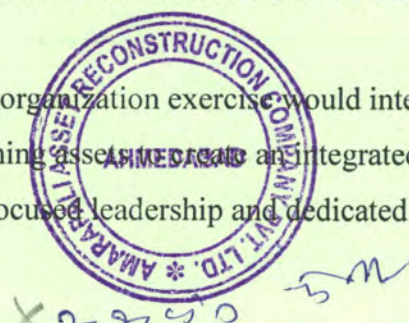
This Scheme is presented under Sections 230 to 232 and other relevant provisions of the Companies Act, 2013 for demerger of the Entertainment division of Amrapali Industries Limited ("AIL") into Amrapali Asset Reconstruction Company Private Limited ("AARCPL")

AIL has two different divisions namely trading of Commodities and Shares and entertainment business. With a view to achieving operational efficiencies and streamlining its current structure, AIL has decided to demerge its Entertainment Division into AARCPL with primary intention to focus its business synergies on Share and Commodities trading.

The transfer and vesting of the Entertainment Division of AIL to AARCPL pursuant to this Scheme is with a view to establishing highest operational standards and also to unlock the economic value of the Entertainment Division

The re-organization exercise would inter alia achieve the following advantages:

- i. Realigning assets into an integrated business model;
- ii. More focused leadership and dedicated management;



iii. Greater visibility on the performance of Share and Commodities trading.

In view of the aforesaid, the Board of Directors of both the Companies have considered and proposed the Scheme of Arrangement in the nature of De-merger and transfer of Entertainment Division of AIL to AARCPL under the provisions of 230 to 232 of the Companies Act, 2013 and the applicable provisions of the Companies Act, 2013.

D. The Proposed Scheme, with effect from the Appointed Date is in the interest of the shareholders, creditors, stakeholders and employees, as it would enable a focused business approach for the maximization of benefits to all stakeholders and for the purpose of synergies of business.

E. This Scheme is divided into the following parts:

**PART I** : This part deals with the definitions and share capital of the Demerged Company and Resulting company;

**PART II** : This part deals with the demerger of the Maintenance of Entertainment undertaking of the Demerged Company into the resulting Company; and

**PART III** : This part deals with general terms and conditions as applicable to the Scheme.

## PART I

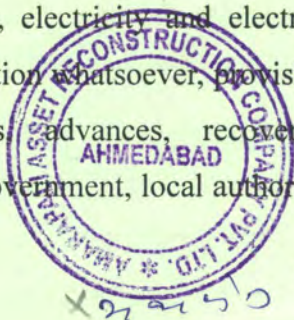
### 1. DEFINITIONS

In this Scheme, unless inconsistent with the subject or context, the following expressions shall have the meanings respectively assigned against them:

- 1.1. "Act" or "The Act" means the Companies Act, 1956 and shall include the relevant and corresponding sections under the Companies Act, 2013 and any rules, regulations, circulars or guidelines issued there under, as amended from time to time and shall include any statutory replacement or re-enactment thereof.
- 1.2. "Appointed Date" for the purpose of this Scheme means 1st Day of April, 2021 or such other date as the Hon'ble Tribunal may approve;
- 1.3. "Board of Directors" or "Board" means board of directors of Demerged and/or Resulting Company, as the case may be and shall, unless it is repugnant to the context or otherwise, include a committee of Directors or any person authorised by the Board of Directors or such committee of Directors;



- 1.4. "BSE" means the BSE Limited, the designated stock exchange of the Demerged Company.
- 1.5. "Competent Authority" means the National Company Law Tribunal ("NCLT") as constituted and authorized as per the provisions of the Companies Act, 2013 for approving any scheme of arrangement, compromise or reconstruction of companies under the relevant provisions of the Act.
- 1.6. "Demerged Company" shall have a meaning as ascribed to it under Recital B (i) of this Scheme above;
- 1.7. "Demerged Undertaking / Identified Undertaking" means the Entertainment Business (as defined hereinafter) of the Demerged Company, comprising, inter-alia, of all the properties, assets, liabilities, permits licenses, registrations, approvals, contracts and employees, on a going concern basis, representing an undertaking in compliance with Explanation 1 to Section 2(19AA) of the IT Act (as defined hereinafter), and includes:
- a) All the assets and properties as on the Appointed Date (hereinafter referred to as "the said assets") pertaining to the Demerged Undertaking;
  - b) All the debts, liabilities, duties and obligations including contingent liabilities pertaining to the Demerged Undertaking;
  - c) Without prejudice to the generality of above, the Demerged Undertaking shall include rights over land, buildings, the movable properties covering plant and machinery, equipment, furniture, fixtures, vehicles, leasehold assets and other properties, real, corporeal and incorporeal, in possession or reversion, present and contingent assets (whether tangible or intangible) of whatsoever nature, assets including cash in hand, bank balance, bills of exchange, letter of intents, loans and advances, investments but other than those forming part of Remaining Undertaking, claims, powers, authorities, allotments, approvals, consents, letters of intent, registrations, licenses, contracts, agreements, engagements, arrangements, rights, credits, titles, interests, benefits, advantages, leasehold rights, sub-letting tenancy rights, with or without the consent of the landlord as may be required, goodwill, other intangibles, permits, authorizations, trademarks, trade names, labels, brands, patents, patent rights, copyrights, designs, and other industrial and intellectual properties and rights of any nature whatsoever including labels, designs, know-how, domain names, or any applications for the above, assignments and grants in respect thereof, right to use and avail of telephones, telex, facsimile and other communication facilities, connections, installations and equipment, utilities, electricity and electronic and all other services of every kind, nature and description whatsoever, provisions, funds, and benefits of all agreements, arrangements, deposits, advances, recoverable and receivables, whether from government, semi-government, local authorities or any other person including customers, contractors



or other counter parties, etc., all earnest monies and/or deposits, privileges, liberties, easements, advantages, benefits, exemptions permissions, and approvals of whatsoever nature (including but not limited to benefits of tax relief including under the Income-tax Act, 1961 such as credit for advance tax, taxes deducted at source, minimum alternate tax etc., unutilized deposits or credits, benefits under the GST wheresoever's situate, belonging to or in the ownership, power or possession or control of or vested in or granted in favour of or enjoyed by the Demerged Undertaking.

- d) all records, files, papers, engineering and process information, computer programs, computer software, manuals, data catalogues, quotations, sales and advertising materials, list of present and former customers and suppliers, customers credit information, customers pricing information and other records, whether in physical form or electronic form in connection with or relating to the Demerged Undertaking.
- e) all employees of Entertainment Division of AIL engaged in or in relation to the Demerged Undertaking as on the Effective Date.

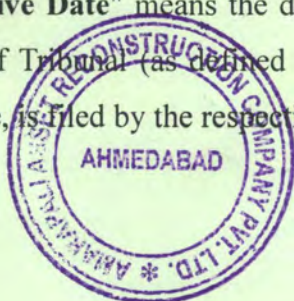
Explanation A: Whether any particular asset or employee should be included as asset or employee of the Demerged Undertaking or otherwise shall be decided mutually by the Board of Directors or any committee thereof of Demerged Company and Resulting Company.

Explanation B: For the purpose of this Scheme, it is clarified that liabilities pertaining to the Demerged Undertaking shall comprise the liabilities, borrowings, debts and loans as agreed between Demerged Company and Resulting Company which will cover:

- a) The liabilities, which arise out of the activities or operations of Demerged Undertaking.
- b) Specific loans and borrowings raised, incurred and utilized solely for the activities or operation of the Demerged Undertaking.

Any question that may arise as to whether a specified liability pertains or does not pertain to the Demerged Undertaking of Demerged Company or whether it arises out of the activities or operations of Demerged Undertaking of Demerged Company shall be decided by mutual agreement between the Board of Directors or any Committee thereof of Demerged Company and Resulting Company.

1.8. "Effective Date" means the date or last of the dates on which the certified copies of the order of Tribunal (as defined hereinafter), under section 232 of the Act, sanctioning this Scheme, is filed by the respective Companies with RoC (as defined hereinafter);





Provided that references in this Scheme to the date of "upon coming into effect of the Scheme" or "upon the Scheme becoming effective" or "effectiveness of the Scheme" shall mean Effective Date;

- 1.9. "**Governmental and Registration Authority**" means any relevant Central, State or local government, legislative body, regulatory or administrative authority, agency or commission or any court, tribunal, board, quasi-judicial body, bureau or instrumentality thereof or arbitral body having jurisdiction over the Companies;
- 1.10. "**IT Act**" means the Income Tax Act, 1961 and the rules made there under and shall include any statutory modification(s), amendment(s) or re-enactment(s) thereof for the time being in force;
- 1.11. "**Listing Regulations**" means Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and shall include any statutory modification(s), amendment(s) or re-enactment(s) thereof for the time being in force as applicable to the Scheme;
- 1.12. "**Remaining Undertaking**" means all business and undertaking of the Demerged Company other than the Demerged Undertaking.
- 1.13. "**RoC**" or "**Registrar of Companies**" means the Registrar of Companies, Ahmedabad;
- 1.14. "**Record Date**" means such date after the Effective Date when the Board of Directors of the Resulting Company may decide for the purposes of issue and allotment of Equity Shares under the Scheme.
- 1.15. "**Scheme**" means this scheme of arrangement in its present form as submitted to the Tribunal (as defined hereinafter) or this Scheme with such modification(s), if any, as may be directed by members and/or creditors of respective Companies or such modifications(s) as may be imposed by any Governmental and Registration Authority and accepted by Board of Companies and/or directed to be made by the Tribunal while sanctioning the Scheme;
- 1.16. "**SEBI**" means the Securities and Exchange Board of India established under the Securities and Exchange Board of India Act, 1992;
- 1.17. "**SEBI Circulars**" means Circular No. CFD/DIL3/CIR/2017/21 dated March 10, 2017 read with Circular No. CFD/DIL3/CIR/2017/26 Dated March 23, 2017, CFD/DIL3/CIR/2017/105 dated September 21, 2017, CFD/DIL3/CIR/2018/105 dated January 3, 2019 and CFD/DIL1/CIR/P/2019/192 dated September 12, 2019 each issued by SEBI, as amended, substituted or replaced from time to time;

## 3. TRANSFER AND VESTING OF DEMERGED UNDERTAKING OF DEMERGED COMPANY WITH INTO RESULTING COMPANY :

Upon the Scheme becoming effective and with effect from the Appointed Date, the Identified Undertaking of the Demerged Company shall stand transferred to and vested in or deemed to be transferred to and vested in the Resulting Company, as a going concern, in the following manner:

- 3.1 Upon the Scheme becoming effective and with effect from the Appointed Date, the whole of the Identified Undertaking and all the properties, tangible and intangible, relating to the Identified Undertaking shall, pursuant to the provisions contained in the Section 230 to 240 and all other applicable provisions, if any, of the Act and without any further act, deed, matter or thing, stand transferred to and vested in and/or be deemed to be transferred to and vested in the Resulting Company on a going concern basis so as to vest in the Resulting Company all rights, title and interest relating to the Identified Undertaking.
- 3.2 Upon the Scheme becoming effective and with effect from the Appointed Date, all the immovable properties, if any, of the Identified Undertaking, whether freehold or leasehold and any documents of title and right thereto shall stand transferred and vested in Resulting Company and shall become the property and integral part of the Resulting Company, without any further act, instrument or deed required by either of the Resulting Company or Demerged Company and without requirement of any approval or acknowledgement of any third party.
- 3.3 In respect of such assets and properties of the Identified Undertaking as are movable in nature or incorporeal property or are otherwise capable of transfer by delivery or possession, or by endorsement and/ or delivery, including cash-in-hand the same shall be physically handed over by delivery to the Resulting Company by the Demerged Company upon coming into effect of the Scheme and shall, ipso facto and without any other order to this effect, become the assets and properties of the Resulting Company.
- 3.4 In respect of the assets other than those dealt within sub-clause 3.3 above and forming part of the assets, including but not limited to sundry debts, receivables including tax balance, bills, credits, loans, advances and deposits, if any, pertaining to the Identified Undertaking, whether recoverable in cash or in kind or for value to be received, the same shall stand transferred to and vested in the Resulting Company without any notice or other intimation to any person in pursuance of the provisions of Sections 230 to 240 of the Companies Act, 2013, read with other relevant provisions of the Act to the end and intent that the right of the Demerged Company to recover or realize the same stand transferred to the Resulting Company. The Resulting Company shall, at its sole discretion but without being obliged, give notice in such form as it may deem fit and proper, to such person, as the case may be, that the said debt, receivables, bills, credit, loans, advances or deposit stand transferred and vested in the Resulting Company and that appropriate modification should be made in their respective books/ records to reflect the aforesaid changes and the Demerged Company shall provide all necessary assistance required in this regard.

- 3.5 Upon the Scheme becoming effective and with effect from the Appointed Date, all debts, liabilities (other than any liability pertaining to any tax or tax related litigations), contingent liabilities, duties and obligations of every kind, nature and description of the Demerged Company pertaining to Identified Undertaking under the provisions of the Sections 230 to 240 and all other applicable provisions, if any, of the Act, and without any further act or deed, be transferred to or be deemed to be transferred to the Resulting Company, so as to become from the Appointed Date, the debts, liabilities, contingent liabilities, duties and obligations of the Resulting Company and its shall not be necessary to obtain the consent of any third party or other person who is a party to any contract or arrangement by virtue of which such debts, liabilities, contingent liabilities, duties and obligations have arisen in order to give effect to the provisions of this sub-clause.
- 3.6 On and from the effective Date, till such time that the bank accounts in the name of the Demerged Company in relation to the Identified Undertaking have been replaced with that of the Resulting Company, the Resulting Company shall be entitled to maintain and operate such bank accounts of the Demerged Company, in the name of the Demerged Company for such time as may be determined to be necessary by the Resulting Company. All cheques and other negotiable instruments, payment orders received or presented for encashment which are in the name of the Demerged Company, in relation to the Identified Undertaking, after the Effective Date shall be accepted by the bankers of the Resulting Company and credited to the account of the Resulting Company.
- 3.7 Upon the Scheme becoming effective and with effect from the Appointed Date, any statutory licenses, permission or approvals or consents held by Demerged Company required to carry on operations of the Identified Undertaking shall stand vested in or transferred to Resulting Company without any further act or deed, and shall be appropriately mutated by the statutory authorities concerned therewith in favour of Resulting Company and the benefit of all statutory and regulatory permissions, environmental approvals and consents, registration or other licenses, and consents shall vest in and become available to Resulting Company as if they were originally obtained by Resulting Company. In so far as the various incentives, subsidies, rehabilitation schemes, special status and other benefits or privileges enjoyed, granted by any government body, local authority or by any other person, or availed of by Demerged Company relating to the Identified Undertaking, are concerned, the same shall vest with and be available to Resulting Company on the same terms and conditions as applicable to Demerged Company, as if the same had been allotted and/or granted and/ or sanctioned and/or allowed to Resulting Company.



3.8 It is clarified that if any assets, (estate, claims, rights, title, interest in, or authorities relating to such assets) or any contract, deeds, bonds, agreements, schemes, arrangements or other instruments of whatsoever in relations to Identified Undertaking which Demerged Company owns or to which Demerged company is a party and which cannot be transferred to Resulting Company for any reason whatsoever, Demerged Company shall hold such assets or contact, deeds, bonds, agreements, schemes, arrangements or other instruments of whatsoever nature in trust for the benefit of Resulting Company to which the Identified Undertaking is being transferred in terms of this Scheme, in so far as it is permissible so to do, till such time as the transfer is effected.

#### 4. Conversion and Change of Name of Resulting Company to Conversion and Change of Name and its Memorandum and Article of Resulting Company

4.1 Once the Demerged Company receives the Observation from BSE on the Scheme under Regulation 37 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and as the Scheme gets approved by the NCLT, the Resulting Company shall be converted into Public Company and shall eventually adopt new sets of Article of Association as per the Companies Act, 2013 or as may be acceptable or approved by the BSE.

4.2 The Resulting Company shall changed the name of the company to "ARK ENTERTAINMENT LIMITED" or such other name which is available and approved by the ROC by filing the requisite forms.

4.3 The Resulting Company will shuffle their "Object no. (C) 15 of Other Object to the Main Object no. 4" by filing the requisite forms.

"15. To carry on any where in the world, the business of hotel in all its aspects, lodging and boarding and to run, manage, acquire, control, own, purchase, hire the same including restaurant, cafe tavern, refreshment-room, lodging-house keepers, licenced victuallers, subject to law, wine, beer and spirit merchants, importers and dealers of areated, minerals and artificial waters and other drinks, purveyors, caterers for public amusements, ice merchants, importers and workers of food, live and dead stock and colonial and foreign producers of all descriptions, hair dressers, perfumers, properties of clubs, baths, dressing rooms, laundries, reading, writing and newspapers, rooms, libraries, grounds and place of amusement, recreation, sports, dance and entertainments of all kinds and cigar merchants, agents for railways, shipping and airplane companies, carries, theatrical and operabox office properties, entrepreneurs and general agents of things which can be conveniently carried on in connection therewith."

4.4 It is herby clarified that, for the purpose of the acts and events as mentioned in Point 4.1, 4.2 and 4.3 the consent of shareholders of the Resulting Company to this Scheme shall be deemed to be sufficient for the purpose of effecting the aforesaid mentioned amendment and that no further resolution under Section 13 and 14 or any other applicable provisions of the Act, would required to be separately passed or as may be acceptable or approved by the BSE.

## 5. CONSIDERATION

5.1. Upon this Scheme becoming effective and upon vesting of the Entertainment Business of Demerged Company in Resulting Company in terms of this Scheme, Resulting company shall without any further application or deed, issue and allot equity shares, credited as fully paid-up, to the extent indicated below, to the equity shareholders of Demerged company and whose names appear in the Register of Members of Demerged Company on the Effective Date or to such of their respective heirs, executors, administrators or other legal representative or other successors in title as may be recognized by the Board of Directors of Resulting Company in the following manner:

1 (One) fully paid up Equity Share of Rs. 10/- each of Resulting Company shall be issued

and allotted for every 15 (Fifteen) fully paid up Equity Shares of Rs. 5/- each held in Demerged Company.

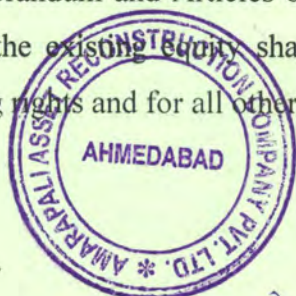

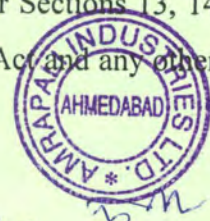
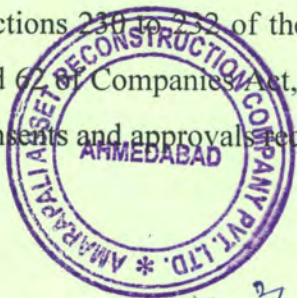
5.3. Mr. Amrish Gandhi, Registered Valuer, Regn. No. IBBI/RV/03/2019/12508, has issued the report on the aforementioned share entitlement ratio. M/s Guinness Corporate Advisors Private Limited., Category-I, Merchant Banker, has provided its fairness opinion on the aforesaid share entitlement ratio. The aforesaid share entitlement ratio and fairness opinion have been duly considered by the Board of the Demerged Company and the Resulting Company;

5.4. The New Equity Shares shall be issued and allotted in dematerialized form to the equity shareholders of Demerged Company. If the Resulting Company has received notice from any member that New Equity Shares are to be issued in physical form or if any member has not provided any requisites details relating to his account with a depository participant or other confirmation as may be required or if the details furnished by any member do not permit electronic credit of New Equity Shares, then the Resulting Company shall issue New Equity Shares in physical form to such member or members.

5.5. The New Equity Shares to be issued and allotted as above shall be subject to the Memorandum and Articles of Association of Resulting Company and shall rank pari passu with the existing equity shares of resulting Company in all respects including dividends, voting rights and for all other benefits and in all other respects.



- 5.6. The Resulting Company shall apply for listing of its equity shares including those issued in terms of Clause 5.1 on Stock Exchanges immediately after receipt of the order of Tribunal as per applicable provisions of SEBI Circulars. The Resulting Company shall ensure that steps for listing of equity shares issued in terms of Clause 5.1 of this Scheme are completed and trading in such equity shares commences within sixty days of receipt of the order of the Tribunal, simultaneously on all the Stock Exchanges;
- 5.7. The equity shares allotted pursuant to the Scheme shall remain frozen in the depository system till listing/trading permission is given by the designated stock exchange;
- 5.8. There will be no change in the shareholding pattern of Amrapali Assets Reconstruction Company Private Limited between the record date and the listing Approval.
- 5.9. The Board of Directors of Resulting Company shall, if and to the extent required, apply for and obtain any approvals from concerned Government/ Regulatory authorities for the issue and allotment of New Equity Share.
- 5.10. In the event of there being any pending share transfers with respect to the application lodged for transfer by any shareholder of Demerged Company, the Board of Directors, or failing which the Board of Director of Resulting Company shall be empowered in appropriate case, even subsequent to the Record Date to effectuate such a transfer in Demerged Company as if such changes in registered holder were operative as on the Record Date, in order to remove any difficulties arising to the transferor or the transferee of the share(s) in Demerged Company and in relation to the Demerged Company Equity Shares after the Schemes becomes effective.
- 5.11. New Equity Shares to be issued and allotted by Resulting Company to the equity shareholders of Demerged Company pursuant to Clause 5.1 of this Scheme, in respect of any equity shares in Demerged Company which are held in abeyance under the provisions of Section 126 of the Act, pending allotment or settlement of dispute, by order of court or otherwise, be held in abeyance by Resulting Company.
- 5.12. Approval of this Scheme by the equity shareholders of Resulting Company shall be deemed to be due compliance of the provisions of Section 61 of the Act and the other relevant and applicable provisions of the Act for the issue and allotment of New Equity Shares by Resulting Company, as provided in this Scheme.

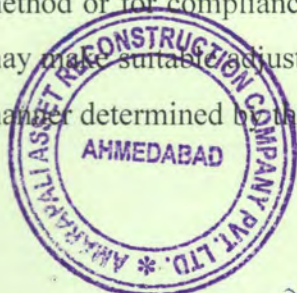
6.1. The Demerged Company and Resulting Company shall account for the Scheme in their respective books/financial statements in accordance with applicable Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015, as amended from time to time including as provided herein below:

### 6.2. In the books of the Demerged Company :

- a) All the assets, liabilities and reserves pertaining to the Demerged Undertaking, which cease to be the assets, liabilities and reserves of the Demerged Company, will be reduced from the books of accounts of the Demerged Company at their respective book values, as appearing immediately before the Appointed Date.
- b) The difference if any, between the value of assets of the Demerged Undertaking and the aggregate of the book values of the liabilities and reserves of the Demerged Undertaking, shall be transferred to the Capital Reserve Account.

### 6.3. In the books of the Resulting Company:

- a) The Resulting Company shall record the assets, liabilities and reserves pertaining to the Demerged Undertaking vested in it pursuant to this Scheme, at the respective book values as appearing in the books of the Demerged Company, immediately before the Appointed Date.
- b) The Resulting Company shall credit to the Share Capital Account, in the books of accounts, the aggregate face value of the new equity shares issued by it to the shareholders of the Demerged Company.
- c) The difference if any, between the value of assets of the Demerged Undertaking (as recorded pursuant to (a) above) and the aggregate of the book values of the liabilities and reserves of the Demerged Undertaking, the amount credited to the share capital account pursuant to Clause 5 above, after taking into effect the amount of share capital as reduced shall be transferred to the Capital Reserve Account in the books of the Resulting Company. The shortfall, if any, shall be debited to Goodwill account of Resulting Company.
- d) If considered appropriate for the purpose of application of uniform accounting policies and method or for compliance with the applicable accounting standards, the Resulting Company may make suitable adjustment to the accounting treatment and adjust the effect thereof in the manner determined by the Board of the Resulting Company.





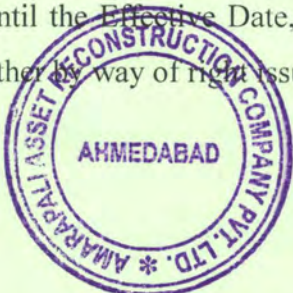
## 7. TAXATION MATTERS

- 7.1. Upon the Scheme becoming effective and with effect from the Appointed Date, all the taxes, duties, cess paid or payable by the Demerged Company (including under the Income Tax Act, 1961 or any other applicable laws) pertaining to the Entertainment Business including but not limited to IGST, CGST, SGST, GST, advance taxes, tax deducted at source, withholding tax, credits, refunds, claims or interest thereon, if any, shall for all purpose, be treated as IGST, CGST, SGST, GST, advance taxes, tax deducted at sources, withholding tax, credit, refunds, claims or interest of the Resulting Company.
- 7.2. Upon the Scheme becoming effective and with effect from the Appointed Date, the Resulting Company is expressly, permitted to revise and file returns pertaining to the Entertainment Business belonging to Demerged Company, including but not limited to income tax returns, tax deducted at source return, sale tax/ value added tax returns, excise return, service tax returns, IGST, CGST, SGST, GST return and other tax returns filed with the governmental and other authorities.
- 7.3. All expenses incurred by the Demerged Company under Section 43B of the Income Tax Act, 1961, in relation and pertaining to the Entertainment Business shall be claimed as a deduction by the Resulting Company and the transfer of the Demerged Undertaking shall be considered as succession of business by the Resulting Company.
- 7.4. All the expenses incurred by the Demerged Company and the Resulting Company in relation to the Scheme, including stamp duty expenses, if any, shall be allowed as deduction to each of the Demerged Company and the Resulting Company in accordance with Section 35DD of the Income Tax Act, 1961.

## 8. PROFIT, DIVIDEND, BONUS/RIGHT SHARES

Demerged Company shall not utilize profits or income, if any, of the Entertainment Business for any purpose including declaring or paying any dividend in respect of the period falling on and after the Appointed Date. Demerged Company shall also not utilize profits, adjust or claim adjustment of the profits/loss as the case may be earned/ incurred or suffered in respect of the Entertainment Business after the Appointed Date.

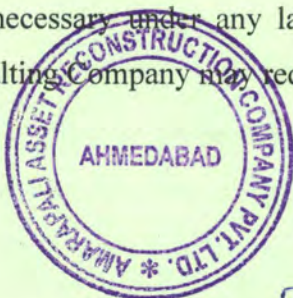
Until the Effective Date, Demerged Company shall not issue or allot any further equity share either by way of right issue or bonus issue or otherwise.



## 9. CONDUCT OF BUSINESS UNTIL THE EFFECTIVE DATE

With effect from the Appointed Date and upto and including the Effective Date:

- 9.1. Demerged Company shall be deemed to have been carrying on and shall carry on its business and activities relating to Entertainment Business and shall be deemed to have been held and stood possessed of and shall hold and stand possessed of all its properties and assets pertaining to the Entertainment Business for and on account of and in trust for Resulting Company. Demerged Company hereby undertakes to hold its said assets with utmost prudence until the Effective Date.
- 9.2. Demerged Company shall carry on its business and activities relating to Entertainment Business with reasonable diligence, business prudence and shall not, except in the ordinary course of business or without prior written consent of Resulting Company, alienate charge, mortgage, encumber or otherwise deal with or dispose of Entertainment Business or part thereof.
- 9.3. All the profits or income accruing or arising to Demerged Company or expenditure or losses arising or incurred or suffered by Demerged Company pertaining to the Entertainment Business shall for all purposes be treated and be deemed to be accrued as the income or profits or losses or expenditure as the case may be of Resulting Company.
- 9.4. Demerged Company shall not vary the terms and conditions of employment of any of the employees of Entertainment Business except in the ordinary course of business or without the prior consent of Resulting Company or pursuant to any pre-existing obligation undertaken by Demerged Company, as the case may be, prior to the Effective Date;
- 9.5. All loans raised and all liabilities and obligations incurred by the Demerged Company with respect to the Entertainment Business after the Appointed Date and prior to the Effective Date, shall subject to the terms of this Scheme, be deemed to have been raised, used or incurred for and on behalf of the Resulting Company and to the extent they are outstanding on the effective Date, shall also, without any further act or deed be and be deemed to become the debts, liabilities, duties and obligations of the resulting Company;
- 9.6. Demerged Company shall be entitled, pending the sanction of the Scheme, to apply to the Central/State Government, and all other agencies, departments and authorities concerned as are necessary under any law or rules, for such consents, approvals and sanctions, which Resulting Company may require pursuant to this Scheme.



## 10. EMPLOYEES

10.1. On the Scheme becoming operative, all staff and employees on the rolls of Demerged Company engaged in the Entertainment Business and who are duly identified or specified as such by the Board of Directors as at the Effective Date shall be deemed to have become staff and employees of Resulting Company without any break in their service and on the basis of continuity of service, and the terms and conditions of their employment with Resulting Company shall not be less favorable than those applicable to them with reference to their employment in Demerged Company.

10.2. It is expressly provided that, on the Scheme becoming effective, the Provident Fund, Gratuity Fund, superannuation Fund or any other Special Fund or Trusts, if any, created or existing for the benefit of the staff and employee of Entertainment Business or all purposes whatsoever in relation to the administration or operation of such Fund or Fund or in relation to the obligation to make contributions to the said Fund or Funds in accordance with the provisions thereof as per the terms provided in the respective Trust Deeds, if any, to the end and intent that all rights, duties, powers and obligations of Demerged Company in relation to Entertainment Business in relation to such Fund or Funds shall become those of Resulting Company. It is clarified that the services of the staff and employees of Entertainment Business will be treated as having been continuous for the purpose of the said Fund or Funds.

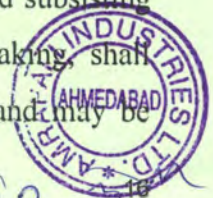
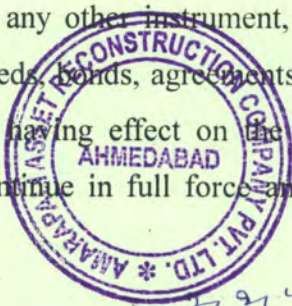
## 11. LEGAL PROCEEDINGS

11.1. If any suit, appeal or other proceeding of whatever nature by or against Entertainment Business is pending, the same shall not abate or be discontinued or in any way be prejudicially affected by reason of or by anything contained in this Scheme, but the said suit, appeal or other legal proceedings may be continued, prosecuted and enforced by or against Resulting Company, as the case may be, in the same manner and to the same extent as it would or might have been continued, prosecuted and enforced by or against the Entertainment Business as if this Scheme had not been made.

11.2. In case of any litigation, suits, recovery proceedings which are to be intimated or may be imitated against Entertainment Business, Resulting Company shall be made party thereto and any payment and expenses made thereto shall be the liability of Resulting Company.

## 12. CONTRACTS, DEEDS, ETC.

12.1. Notwithstanding anything to the contrary contained in the contract, deed, bond, agreement or any other instrument, but subject to the other provisions of this Scheme, all contracts, deeds, bonds, agreements and other instruments, if any, of whatsoever nature and subsisting or having effect on the Effective Date and relating to the Demerged Undertaking, shall continue in full force and effect against or in favour of Resulting Company and may be



enforced effectively by or against Resulting Company as fully and effectually as if, instead of Demerged Company, Resulting Company had been a party thereto.

12.2. Resulting Company, at any time after the coming into effect of this Scheme in accordance with the provisions hereof, if so required, under any law or otherwise, enter into, or issue or execute deeds, writings, confirmations, novations, declarations, or other documents with, or in favour of any party to any contract or arrangement to which Demerged Company is a party or any writings as may be necessary to be executed in order to give formal effect to the above provisions. Resulting Company shall, be deemed to be authorised to execute any such writings on behalf of Demerged Company and to carry out or perform all such formalities or compliances required for the purposes referred to above on the part of Demerged Company.

### 13. SAVING OF CONCLUDED TRANSACTIONS

The transfer of assets, properties and liabilities above and the continuance of proceedings by or against Resulting Company above shall not affect any transaction or proceedings already concluded in Demerged Company, in relation to the Demerged Undertaking on or after the Appointed Date till the Effective Date, to the end and intent that Resulting Company accepts and adopts all acts, deeds and things done and executed by Demerged Company, in relation to the Demerged Undertaking in respect thereto as done and executed on their behalf of Resulting Company.

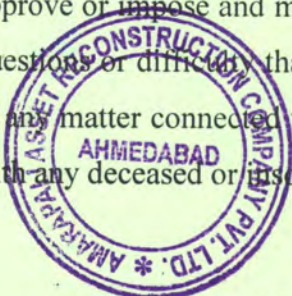
## PART III - GENERAL TERMS AND CONDITIONS

### 14. APPLICATION TO THE COMPETENT AUTHORITY

The Demerged Company and Resulting Company shall make necessary applications before the NCLT, Ahmedabad Bench for the sanction of this Scheme of Arrangement under Sections 230 to 232 read with Sections 52 and 66 of the Act. Any further approval under the Act arising from the Scheme shall be deemed to have been granted, without any application, for any transaction among the Demerged Company and the Resulting Company and/ or its Directors.

### 15. MODIFICATIONS/AMENDMENTS TO THE SCHEME

15.1. The Demerged Company (through its Board of Directors) and the Resulting Company (through its Board of Directors) may, in their full and absolute discretion, assent to any alterations or modifications in this Scheme which the Competent Authority may deem fit to approve or impose and may give such directions as they may consider necessary to settle any questions or difficulties that may arise under the Scheme or in regard to its implementation or in any matter connected therewith (including any question or difficulty arising in connection with any deceased or insolvent shareholder of the respective Company).



15.2. In the event that any conditions are imposed by the Competent Authority which the Demerged Company and/or the Resulting Company find unacceptable for any reason whatsoever then the Demerged Company and/or the Resulting Company shall be entitled to withdraw from the Scheme.

#### 16. CONDITIONALITY OF THE SCHEME:

This Scheme is and shall be conditional upon and subject to:

- 16.1. The requisite consent, approval or permission from the Stock Exchanges and/or SEBI pursuant to Regulation 37 of the Listing Regulations read with SEBI Circulars and Regulation 11 and 94 of the Listing Regulations which by law or otherwise may be necessary for the implementation of this Scheme in compliance with the provisions of SEBI Circulars;
- 16.2. The scheme is conditional upon scheme being approval by the PUBLIC shareholders through e-voting in terms of para 9 (a) of part I of Annexure I of SEBI circular No. CFD/DIL3/CIR/2017/21 dated March 10, 2017 and the scheme shall be acted upon only if vote cast by the public shareholders in favour of the proposal are more than the number of votes cast by the public shareholders against it.
- 16.3. The approval of the Scheme by the respective requisite majorities in number and value of the shareholders and/or creditors (where applicable) of the Companies in accordance with Section 230 to 232 of the Act;
- 16.4. The Scheme being sanctioned by the Tribunal in terms of Sections 230 to 232 and other relevant provisions of the Act and the requisite orders of the Tribunal; and
- 16.5. Certified copies of the orders of the Tribunal sanctioning this Scheme being filed by the Companies with the Registrar of Companies as per the provisions of the Act.

#### 17. EFFECT OF NON-RECEIPT OF APPROVALS

17.1. In the event of any of the approvals or conditions enumerated in the Scheme not being obtained or complied, or for any other reason, this Scheme cannot be implemented, then the Board of Directors of Demerged Company and Resulting Company shall mutually waive such conditions as they consider appropriate to give effect, as far as possible, to this Scheme and failing such mutual agreement the Scheme shall become null and void and each party shall bear and pay their respective costs, charges and expenses in connection with this Scheme.



## 18. EFFECTIVE DATE OF THE SCHEME:

18.1. This Scheme shall become effective when all the following conditions are fulfilled:

- i. The Scheme being approved by the requisite majority of the shareholders and creditors of the Demerged Company and the Resulting Company as may be required under the Act and/or the orders of the Competent Authority.
- ii. The Scheme is sanctioned by the said Competent Authority under Section 230 to 232 of the Act.
- iii. The certified copy of the order of the said Competent Authority sanctioning the Scheme is filed with the Registrar of Companies, Ahmedabad.

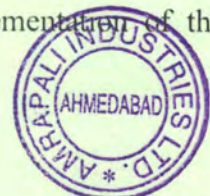
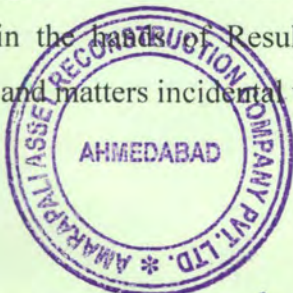
## 19. MISCELLANEOUS

Save and except as provided in the Scheme, the Resulting Company shall bear all costs incurred in relation to fees of legal counsels, consultants and professionals engaged by the Resulting Company, stamp duty payable on the order of Hon'ble Tribunal approving the Scheme, issue of shares to the shareholders of Demerged Company, stamp duty and registration charges on mutation of immovable properties belonging to the Demerged Undertaking, fee for increasing the authorized share capital of the Resulting Company and any income tax liability arising in the hands of the Resulting Company in connection with the implementation of the Scheme and matters incidental thereto.

## **VALUATION: A SUBJECTIVE CONCEPT**

The value of a company's equity share is a very subjective concept. It depends on many variables and factors which are not controllable. Valuation of the enterprise of its equity shares is not an exact science and ultimately depends upon what it is worth to a serious investor or buyer who may be even prepared to pay goodwill. This exercise may be carried out based on the generally accepted methodologies, the relative emphasis of each often varying with the factors such as;

- Specific nature of the business
- Listing and liquidity of the equity
- Economic life cycle in which the industry or the company is operating and



- Extent to which find comparable company information is available

The results of this exercise could vary significantly depending upon the basis used, the specific circumstances and professional judgment of the valuer. In respect of going concerns, certain valuation techniques have evolved over time and commonly in vogue.

1. The value of shares of a company depends on various factors such as its intrinsic net worth; its earning capacity and the price at which a willing buyer is ready to acquire the shares in an open market at arm's length transaction. Accordingly, the alternative methods of share valuation try to consider the above factors while determining the value of the shares of any company. Based on these factors there are principally three methods of share valuations namely the Asset Approach, Income Approach and the Market Price Approach. There is also the Income Based Valuation Approach under which the principal valuation method is the Discounted Cash Flow Method. Each method proceeds on different fundamental assumptions, which have greater or lesser relevance, and at time, even no relevance, to a given situation. Thus the methods to be adopted for a particular valuation must be judiciously chosen. We have, therefore, made an exercise to determine value per share of AIL in accordance with these methods as applicable in the given scenario.
2. The detailed Rules and Principles involved in share valuation are laid down by law, statutory guidelines, and decisions of courts as well as established valuation practices.
3. **Asset Approach** represents the value of a share with reference to the historical cost of the assets owned by the company and the attached liabilities on the valuation date. Such value represents the support value of a share on a going concern. It is usual to ignore the market value of the assets under this method. However, in case of change of ownership, sale of controlling stake or similar conditions, adjustments to book values may be required in accordance to the replacement costs or market valuations of these assets. While the historical cost is adopted in respect of the assets which are to be continued as a part of the going concern, it is necessary to adjust the realisable value of assets in case the going concern concept is compromised or is not applicable. Example of such as a case is a company under liquidation. Sometimes, to determine the current net worth of the company, the historical cost figures and the valuations of other noncurrent assets and investments are adjusted to represent their approximate current worth.

Normally for the purpose of calculation the audited figures for the last financial year are to be considered. However if there are event after the closure of accounts which has material effect on the NAV it would be appropriate to consider those effect. There are significant events occurred after closing of last financial year and therefore, we have considered audited figures of financial year ended on 31st March, 2019.

4. **The Discounted Cash Flow (Income Approach)** method uses the future cash flows of the company discounted by the cost of capital to arrive at the present value. In general, the DCF method values the company by discounting its free cash flows for the explicit forecast period and the perpetuity value thereafter. The free cash flows represent the cash available for distribution to both the owners and creditors of the company.

The Major turnover of the AIL is in the trading of Silver and Gold, out of three Audited Financial years the AIL had incurred losses. The certainty of income cannot be predictable and being in Commodity trading, it is not prudent to value the shares of the AIL on the basis of Income Approach.

The AARPL has not commenced any activity and the activity of entertainment will start after the transfer of entertainment activity. Hence the Income approach is not considered for valuation of AARPL.

5. **Market Approach** evaluates the share on the basis of the transactions entered on the stock exchange. The rate as per this method is considered as indicative of the value perception for the shares by investors operating under free market conditions. In this case the company is not frequently traded, the value may be very different from the inherent value of shares, but nevertheless forms a benchmark value. The shares are infrequently traded of AIL hence the Market Approach is also not considered for the valuation of shares. For AARPL is an unlisted Company, The market approach is not applicable.

In the present case, the shares of AIL are listed on BSE and the volume weighted average price of AIL over as appropriate period prescribed under SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2009 ("ICDR Regulations") prior to the relevant date has been considered for determining the value of AIL under this method.

#### 1. AMRAPALI INDUSTRIES LIMITED (AIL)

Amrapali Industries Limited ("AIL" or the "Demerged Company") was originally incorporated as Amrapali Synthetics Private Limited under the Companies Act, 1956 vide certificate of incorporation dated May 10, 1988 issued by the Registrar of Companies, Gujarat, Dadra & Nagar Haveli. The Company was converted into a public limited company and the name was changed to Amrapali Synthetics Limited vide certificate of incorporation dated March 4, 1992. Later on the name of the Company was changed to Amrapali Industries Limited vide certificate of incorporation dated April 8, 1992. AIL got listed with BSE on February 08, 1994. The registered office of the Company is situated at 19/20/21, Third Floor, Narayan Chambers, B/H Patang Hotel, Ashram Road, Ahmedabad-380006. 2. To manufacture, produce, buy, sell, distribute, import, export, deal in all kinds of laminated sheets, fiberwood sheets and their products and bye-products.
3. To do the business of commodity (including commodity derivatives) broking, trading and hedging.
4. To carry on business as brokers and traders in all commodities and commodity derivatives, and to act as market makers, finance brokers, sub-brokers, underwriters, sub-underwriters, providers of service for commodity related activities.
5. To buy, sell, take hold deal in, convert, modify, add value, transfer or otherwise Dispose of commodities and commodity derivatives, and to carry on the above business in India and abroad for and on behalf of the company as well as for others.
6. To apply for and obtain registration as Commodities Broker or Member of any Commodities Exchange anywhere in India and abroad.
7. To do the business of commodity warehousing, processing and consumption.

Amrapali Asset Reconstruction Company Private Limited ("AARCPL" or the "Resulting Company") was incorporated as a private limited company under the provisions of the Companies Act, 1956 vide certificate of incorporation dated January 8, 2010 having its registered office at 19/20/21 3rd Floor, Narayan Chambers, Ashram Road, Ahmedabad-380009. The Corporate Identification Number of the Company is U65190GJ2010PTC059157.

The main objects of the Company as per clause IIIA of the Memorandum of Association are:

- a) To act as a Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and carry on the business of securitization and / or asset reconstruction and for that purpose to acquire and / or deal with and / or dispose off any and all assets, partly or wholly including but not limited to financial assets, property, secured assets, of any nature and otherwise to assist or participate in the securitization, realization or restructuring or reconstruction of financial assets and / or secured assets and for such purpose to mobilize funds in any manner including but not limited to issue of debentures or bonds



or other securities and to offer or otherwise issue or deal in security receipts of any nature and tenor to Qualified Institutional Buyers or any other persons, natural or juristic (as may be permitted under the SRFAESI from time to time) and for the purpose aforesaid or in connection with asset reconstruction or securitization, to act as trustees, managers, administrators, receivers, valuers or otherwise and to engage, appoint, discharge any intermediaries or agents or professional or consultants.

#### **IV. RATIONAL FOR DEMERGER**

- 1. This Scheme is presented under Sections 230 to 232 and other relevant provisions of the Companies Act, 2013 for demerger of the Entertainment division of Amrapali Industries Limited (“AIL”) into Amrapali Asset Reconstruction Company Private Limited (“AARCPL”)

AIL has two different divisions namely trading of Commodities & Shares and Entertainment business. With a view to achieving operational efficiencies and streamlining its current structure, AIL has decided to demerge its Entertainment Division into AARCPL with primary intention to focus its business synergies on Share and Commodities trading.

The transfer and vesting of the Entertainment Division of AIL to AARCPL pursuant to the Scheme is with a view to establishing highest operational standards and also to unlock the economic value of the Entertainment Division.

The re-organization exercise would inter alia achieve the following advantages:

- i. Realigning assets to create an integrated business model;
- ii. More focused leadership and dedicated management;
- iii. Greater visibility on the performance of Share and Commodities trading business.

- 2. As per the draft scheme the Appointed Date for the Demerger is April 1, 2020.

#### **V. VALUATION TECHNIQUES**

By its very nature, valuation work cannot be regarded as an exact science and given the same set of facts and using the same assumptions, expert opinions may differ due to the number of separate judgment decisions, which have to be made. There can therefore be no standard formulae to establish an indisputable value, although certain appropriate formulae are useful in establishing reasonableness.



The basic valuation methodologies adopted can be classified as:

- A. Asset based approach;
- B. Income based approach; and
- C. Market based approach

**A) Asset Based Approach**

The Asset based approach considers the Net Asset value, Replacement value or Realizable value as an indication of the fair market value of respective assets.

**B) Income Based Approach**

The earnings based method considers price earnings capacity value per share, discounted cashflow, earnings multiple method as an indication of the fair value of the share.

**C) Market Based Approach**

The market approach involves identifying comparable companies (usually publicly-listed) within the same segment of the industry and uses the comparable companies financial information to derive various pricing multiples. These multiples are then used in calculating the fair market value.

**VI. VALUATION SUMMARY**

**i. Final Valuation for AIL**

Upon the Scheme becoming effective and with effect from the Appointed Date, the Identified Undertaking of the Demerged Company shall stand transferred to and vested in or deemed to be transferred to and vested in the Resulting Company, as a going concern.

Upon the Scheme becoming effective and with effect from the Appointed Date, all the immovable properties, if any, of the Identified Undertaking, whether freehold or leasehold and any documents of title and right thereto shall stand transferred and vested in Resulting Company and shall become the property and integral part of the Resulting Company.

In our opinion, the share value of each share of Amrapali Industries Limited on the valuation date should be calculated on the basis of the valuations as per the Asset Based Approach.

The valuation as per asset based approach is arriving to Rs. 0.16.

**ii. Final Valuation for AARCPL**

In our opinion, the recommended share value of Amrapali Asset Reconstruction Company Private Limited on the valuation date is Rs. 2.40 considering Net Asset Value per share of the company.



In the opinion of the Board of Directors, all three Independent Directors of the Company meet all the criteria mandated by Section 149 of the Companies Act, 2013 and rules made there under and Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and they are Independent of Management.

A separate meeting of Independent Directors was held on March 30, 2021 to review the performance of Non-Independent Directors and Board as a whole and performance of Chairperson of the Company including assessment of quality, quantity and timeliness of flow of information between Company management and Board that is necessary for the board of directors to effectively and reasonably perform their duties.

The Company has received a declaration from the Independent Directors of the Company under Section 149(7) of Companies Act, 2013 and 16(1)(b) of Listing Regulations confirming that they meet criteria of Independence as per relevant provisions of Companies Act, 2013 for financial year 2021-22. The Board of Directors of the Company has taken on record the said declarations and confirmation as submitted by the Independent Directors after undertaking due assessment of the veracity of the same. In the opinion of the Board, they fulfill the conditions as Independent Directors and are independent of the Management. Further, all the Independent Directors have registered themselves with Independent Directors' Data Bank.

None of Independent Directors have resigned during the year.

### **Information on Directorate**

During the financial year 2020-21, the Board of Directors at its meeting held on March 02, 2021, on the recommendation of the Nomination and Remuneration Committee changed the designation of Mr. Rashmikant Amratlala Thakkar from Whole-time Director to Executive Director of the Company subject to approval of the Shareholders of the Company in the ensuing General Meeting.

As per the provisions of Section 149(10) read with Section 152 and Schedule IV to the Act, Mr. Haresh Chaudhari who was re-appointed at 32<sup>nd</sup> Annual General Meeting of as Independent Director for second term of five (5) consecutive years commencing from July 28, 2021.

Pursuant to Stock Exchange Approval, Ms. Komal Parekh has resigned from the position of Non-executive Director w.e.f April 23, 2021.

On recommendation of Nomination and Remuneration Committee and in pursuance of the articles of the Company, Board of Directors appointed Ms. Bhumi Patel as an Additional Non-executive Director w.e.f April 26, 2021, who shall hold the office up to next ensuing General Meeting.

In accordance with the provisions of the Articles of Association and Section 152 of the Companies Act, 2013, Mr. Yashwant Amratlal Thakkar, Managing Director of the Company retires by rotation at the ensuing annual general meeting. He, being eligible, has offered himself for re-appointment as such and seeks re-appointment. The Board of Directors recommends his appointment on the Board.

### **Key Managerial Personnel**

In accordance with Section 203 of the Companies Act, 2013, the Company has already appointed Mr. Yashwant Thakkar as Chairman and Managing Director of the Company, Mr. Satish Patel as Chief Financial Officer, and Mrs. Ekta Jain as Company Secretary of the Company. Further, during the financial year 2020-21, Mr. Rajendra Bohlabhai Patel was appointed as Chief Executive officer- Entertainment Division of the Company w.e.f 21<sup>st</sup> October, 2020 and also appointed Mr. Satish Patel as Chief Executive officer - Bullion Division Activities w.e.f 25<sup>th</sup> November, 2020.

The re-organization exercise would inter alia achieve the advantage of 1) realizing assets to create an integrated business model, 2) more focused leadership and dedicated management, and 3) greater visibility on the performance of shares and commodities trading.

Moreover, the resulting company i.e. Amrapali Asset Reconstruction Company Private Limited shall apply to the BSE Limited for getting its shares listed on BSE Limited.

The Company has filed Scheme of Demerger with BSE Limited for obtaining its Observation Letter or No-objection letter.

In the Board Meeting held on June 30, 2021, demerger of the Entertainment Business ("Demerged Undertaking") of Amrapali Industries Limited into Amrapali Asset Reconstruction Private Limited and their respective shareholders and creditors ("the Scheme") and the Observation Letters dated March 30, 2021 issued by the stock exchanges to the proposed Scheme approved various changes in the Original Scheme.

## NOMINATION & REMUNERATION POLICY

### 1. Preface:

Pursuant to Section 178 of the Companies Act, 2013 and the Rules framed thereunder (as amended from time to time) (the “Act”) and Regulation 19 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended from time to time) (the “SEBI Listing Regulations”), the Board of Directors of every listed company is required to constitute the Nomination and Remuneration Committee.

Amrapali Industries Limited (“the Company”), in order to attract motivated and retained manpower in competitive market, to harmonize the aspirations of human resources consistent with the goals of the Company and in terms of the provisions of the Companies Act, 2013 and the SEBI (Listing Regulations and Disclosure Requirements) Regulation, 2015 as amended from time to time, this policy on nomination and remuneration of Directors, Key Managerial Personnel and Senior Management has been formulated and recommended by the Nomination and Remuneration Committee and approved by the Board of Directors.

### 2. Objective:

In order to comply with the requirements of Section 178 of the Act and Regulation 19 of the SEBI Listing Regulations and any other applicable provisions, the Nomination and Remuneration Committee of the Board of Directors of the Company (the “Committee”) had formulated this policy (the “Policy”).

The Key Objectives of the Nomination and Remuneration Policy would be:

- A. To formulate the criteria for determining qualifications, competencies, positive attributes and independence for appointment of a Director (Executive / Non-Executive) and recommend to the Board of Directors of the Company (the “Board”), policies relating to the remuneration (payable in whatever form) of the Directors, Key Managerial Personnel and other employees.
- B. To formulate criteria for evaluation of the members of the Board and provide necessary report to the Board for further evaluation of the Board.
- C. To provide to Key Managerial Personnel and Senior Management reward linked directly to their effort, performance, dedication and achievement relating to the Company’s operations.
- D. To retain, motivate and promote talent and to ensure long term sustainability of talented managerial persons and create competitive advantage.
- E. To devise a Policy on Board Diversity.
- F. To develop a succession plan for the Board and to regularly review the plan.
- G. To determine whether to extend or continue the term of appointment of the Independent Director(s), on the basis of the report of performance evaluation of Independent Directors.

### 3. Definition:

- a) “Act” means the Companies Act, 2013 and the Rules framed thereunder, as amended from time to time.
- b) “Board” means Board of Directors of the Company.
- c) “Director” means Directors of the Company.
- d) “Committee” means the Nomination and Remuneration Committee of the Company as constituted or re-constituted by the Board.
- e) “Independent Director” means a Director referred to in Section 149(6) of the Companies Act, 2013.
- f) “Key Managerial Personnel” means:
  - i. Executive Chairman or Chief Executive Officer and/or Managing Director;
  - ii. Wholetime Director;
  - iii. Chief Financial Officer;
  - iv. Company Secretary;
  - v. such other officer, not more than one level below the directors who is in whole-time employment, designated as key managerial personnel by the Board; and
  - vi. such other officer as may be prescribed
- g) “Senior Management” shall mean officers/personnel of the listed entity who are members of its core management team excluding board of directors and normally this shall comprise all members of management one level below the chief executive officer/managing director/whole time director/manager (including chief executive officer/manager, in case they are not part of the board) and shall specifically include Company Secretary and Chief Financial Officer.

Unless the context otherwise requires, words and expressions used in this policy and not defined herein but defined in Companies Act, 2013 as may be amended from time to time shall have the meaning respectively assigned to them therein.

#### **4. Policy on Appointment and removal of Directors, KMPs and Senior Management:**

##### **1) Appointment criteria and qualifications:**

- i. The Committee shall identify and ascertain the integrity, qualification, expertise and experience of the person for appointment as Director, KMP or Senior Management and recommend to the Board his / her appointment.
- ii. A person should possess a adequate qualification, expertise and experience for the position he / she is considered for appointment. The Committee has the discretion to decide whether qualifications, expertise and experience possessed by a person is sufficient / satisfactory for the concerned position.
- iii. The Company shall not recommend or appoint or continue the employment of any person as the Managing Director, Whole-time director or Manager within the meaning of the Act, who has attained the age of 70 (seventy) years. Provided that the appointment of such a person who has attained the age of 70 (seventy) years shall be made with the approval of the Shareholders by passing a special resolution, based on the explanatory statement annexed to the notice for the Meeting of the Shareholders for such motion indicating the justification for appointment or extension of appointment beyond the age of 70 (seventy) years.

##### **2) Tenure of Employment:**

###### **a) Managing Director/Whole-time Director/ Executive Director:**

The Company shall appoint or re-appoint any person as its Executive Chairman, Managing Director or Executive Director for a term not exceeding 5 (five) years at a time. No re-appointment shall be made earlier than 1 (one) year before the expiry of term.

###### **b) Independent Director:**

- i. An Independent Director shall hold office for a term up to 5 (five) consecutive years on the Board and will be eligible for re-appointment on passing of a special resolution by the Company and disclosure of such appointment in the Board's Report.
- ii. No Independent Director shall hold office for more than two consecutive terms, but such Independent Director shall be eligible for appointment after expiry of 3 (three) years of ceasing to become an Independent Director. Provided that an Independent Director shall not, during the said period of 3 (three) years, be appointed in or be associated with the Company in any other capacity, either directly or indirectly.
- iii. At the time of appointment of Independent Director(s) it should be ensured that number of Boards on which such Independent Director serves is restricted to 7 (seven) listed companies as an Independent Director and three listed companies as an Independent Director in case such person is serving as a Whole-time Director of a listed company or such other number as may be prescribed under the Act or the SEBI Listing Regulations.

###### **c) Evaluation:**

The Committee shall carry out evaluation of performance of every Director, KMP and Senior Management at regular intervals (yearly).

The evaluation of performance of the Board, its Committees and Individual Directors to be carried out either by the Board, by the Nomination and Remuneration Committee or by an independent external agency and review its implementation and compliance.

The evaluation of independent directors shall be done by the entire board of directors which shall include –

- (a) performance of the directors; and
- (b) fulfillment of the independence criteria as specified in these regulations and their Independence from the management:

Provided that in the above evaluation, the directors who are subject to evaluation shall not participate.

###### **d) Removal:**

Due to reasons for any disqualification mentioned in the Act or under any other applicable law, rules and regulations, thereunder, the Committee may recommend, to the Board with reasons to be recorded in writing, removal of a Director, KMP or Senior Management, subject to the provisions and compliance of the said Act, such other applicable law, rules and regulations.

###### **e) Retirement:**

The Directors, KMP and Senior Management shall retire as per the applicable provisions of the Act and the prevailing policy of the Company. The Board will have the discretion to retain the Director, KMP, Senior Management in the same position/ remuneration or otherwise even after attaining the retirement age, for the benefit of the Company.

#### **5. Policy on remuneration of Director, KMP and Senior Management Personnel:**

- i. The remuneration / compensation / commission etc. to the Whole-time Director, KMP and Senior Management will be determined by the Committee and recommended to the Board for approval. The remuneration / compensation / commission etc. shall be subject to the prior/post approval of the Shareholders of the Company and Central Government, wherever required.

- ii. The remuneration and commission to be paid to the Whole-time Director shall be in accordance with the percentage / slabs / conditions laid down as per the provisions of the Act.
- iii. Increments to the existing remuneration/ compensation structure may be recommended by the Committee to the Board which should be within the slabs approved by the Shareholders in the case of Whole-time Director or as laid down as per the provisions of the Act.

**1) Remuneration to Whole-time/ Executive/ Managing Director, KMP and Senior Management Personnel;**

- i. The Whole-time / Executive / Managing Director / KMP and Senior Management shall be eligible for a monthly remuneration as may be approved by the Board on the recommendation of the Committee. The breakup of the pay scale and quantum of perquisites including but not limited to, employer's contribution to Provident Fund (P.F.), Superannuation Fund, Pension Scheme, medical expenses, club fees, leave travel allowance, etc. shall be decided and approved by the Board/ the Person authorized by the Board on the recommendation of the Committee and approved by the Shareholders and Central Government, wherever required.

- ii. Minimum Remuneration:

If, in any financial year, the Company has no profits or its profits are inadequate, the Company shall pay remuneration to its Whole-time / Executive / Managing Director in accordance with the provisions of Section 197 of the Act and Schedule V to the Act and if it is not able to comply with such provisions, with the previous approval of the Central Government.

- iii. Provisions for excess remuneration:

If any Whole-time / Executive / Managing Director draws or receives, directly or indirectly, by way of remuneration any such sums in excess of the limits prescribed under the Act or without the prior sanction of the Central Government, where required, he / she shall refund such sums to the Company and until such sum is refunded, hold it in trust for the Company. The Company shall not waive recovery of such sum refundable to it unless permitted by the Central Government.

**2) Remuneration to Non- Executive / Independent Director:**

- i. Remuneration / Commission:

The remuneration / commission shall be in accordance with the statutory provisions of the Act and the Rules made thereunder for the time being in force.

- ii. Sitting Fees:

The Non- Executive / Independent Director may receive remuneration by way of fees for attending meetings of the Board or Committee thereof. Provided that the amount of such fees shall not exceed the maximum amount as provided in the Act, per meeting of the Board or Committee or such amount as may be prescribed by the Central Government from time to time.

- iii. Limit of Remuneration/Commission:

Remuneration/ Commission may be paid within the monetary limit approved by shareholders, subject to the limit not exceeding 1% of the profits of the Company computed as per the applicable provisions of the Act.

- iv. Stock Options:

An Independent Director shall not be entitled to any stock option of the Company.

**6. Membership:**

- a) The Committee shall comprise of at least (3) Directors, all of whom shall be non-executive Directors and at least half shall be Independent Directors.
- b) The Board shall reconstitute the Committee as and when required to comply with the provisions of the Act and the SEBI Listing Regulations.
- c) The quorum for the Meeting of the Nomination and Remuneration Committee shall either be two members or one third of the total strength of the Committee, whichever is higher (including at least one independent director in attendance).
- d) Membership of the Committee shall be disclosed in the Annual Report.
- e) Term of the Committee shall be continued unless terminated by the Board of Directors.

**7. Chairperson:**

- a) Chairperson of the Committee shall be an Independent Director.
- b) Chairperson of the Company may be appointed as a member of the Committee but shall not be a Chairman of the Committee.
- c) In the absence of the Chairperson, the members of the Committee present at the meeting shall choose one amongst them to act as Chairperson.
- d) Chairman of the Nomination and Remuneration Committee meeting could be present at the annual general meeting or may nominate some other member to answer the shareholders' queries.

## **8. Frequency of Meetings:**

The Nomination and Remuneration Committee shall meet at least once a year.

## **9. Committee Members' interests:**

- a) A member of the Committee is not entitled to be present when his or her own remuneration is discussed at a meeting or when his or her performance is being evaluated.
- b) The Committee may invite such executives, as it considers appropriate, to be present at the meetings of the Committee.

## **10. Secretary:**

The Company Secretary of the Company shall act as Secretary of the Committee.

## **11. Duties of the Nomination & Remuneration Committee:**

### ***Duties with respect to Nomination:***

The duties of the Committee in relation to nomination matters include:

- Ensuring that there is an appropriate induction in place for new Directors and members of Senior Management and reviewing its effectiveness;
- Ensuring that on appointment to the Board, Independent Directors receive a formal letter of appointment in accordance with the Guidelines provided under the Act;
- Identifying and recommending Directors who are to be put forward for retirement by rotation.
- Determining the appropriate size, diversity and composition of the Board;
- Setting a formal and transparent procedure for selecting new Directors for appointment to the Board;
- Developing a succession plan for the Board and Senior Management and regularly reviewing the plan;
- Evaluating the performance of the Board members and Senior Management in the context of the Company's performance from business and compliance perspective;
- Making recommendations to the Board concerning any matters relating to the continuation in office of any Director at any time including the suspension or termination of service of an Executive Director as an employee of the Company subject to the provision of the law and their service contract.
- Delegating any of its powers to one or more of its members or the Secretary of the Committee;
- Recommend any necessary changes to the Board; and
- Considering any other matters, as may be requested by the Board.

### ***Duties with respect to Remuneration:***

The duties of the Committee in relation to remuneration matters include:

- to consider and determine the remuneration policy, based on the performance and also bearing in mind that the remuneration is reasonable and sufficient to attract retain and motivate members of the Board and such other factors as the Committee shall deem appropriate all elements of the remuneration of the members of the Board.
- to recommend and approve the remuneration of the Senior Management including key managerial personnel of the Company maintaining a balance between fixed and variable pay reflecting short and long term performance objectives appropriate to the working of the Company.
- to delegate any of its powers to one or more of its members or the Secretary of the Committee.
- to consider any other matters as may be requested by the Board.

## **12. Minutes of Committee Meeting:**

Proceedings of all Meetings must be minuted and signed by the Chairperson of the Committee at the subsequent Meeting. Minutes of the Committee Meetings will be tabled at the subsequent Board and Committee Meeting.

## **13. Deviations from this Policy:**

Deviations on elements of this policy in extraordinary circumstances, when deemed necessary in the interests of the Company, will be made if there are specific reasons to do so in an individual case.

## **14. Amendment:**

This updated policy shall be effective from April 1, 2019.

Any change in the Policy shall be approved by the Board of Directors or any of its Committees (as may be authorized by the Board of Directors in this regard). The Board of Directors or any of its authorized Committees shall have the right to withdraw and / or amend any part of this Policy or the entire Policy, at any time, as it deems fit, or from time to time, and the decision of the Board or

its Committee in this respect shall be final and binding. Any subsequent amendment / modification in the Listing Regulations and / or any other laws in this regard shall automatically apply to this Policy.

## MANAGEMENT DISCUSSION AND ANALYSIS REPORT

### INDUSTRY STRUCTURE AND DEVELOPMENTS

#### Introduction

The gems and jewellery sector plays a significant role in the Indian economy, contributing around 7 per cent to country's GDP and 15 per cent to India's total merchandise export. It employs over 4.64 million people, which is expected to reach 8.23 million by 2022. One of the fastest growing sectors, it is extremely export oriented and labour intensive.

Based on its potential for growth and value addition, the Government declared gems and jewellery sector as a focus area for export promotion. The Government has undertaken various measures recently to promote investment and upgrade technology and skills to promote 'Brand India' in the international market.

India is deemed to be the hub of the global jewellery market because of its low costs and availability of high-skilled labour. India is the world's largest cutting and polishing centre for diamonds, with the cutting and polishing industry being well supported by Government policies. Moreover, India exports 75 per cent of the world's polished diamonds as per statistics from the Gem and Jewellery Export Promotion Council (GJEPC). India's Gems and Jewellery sector has been contributing in a big way to the country's foreign exchange earnings (FEEs). Government has viewed this sector as a thrust area for export promotion. The Indian Government presently allows 100 per cent Foreign Direct Investment (FDI) in the sector through the automatic route. The sector employs over 4.64 million employees, which is expected to touch 8.23 million by 2022.

#### Market size

India's gems and jewellery sector is one of the largest in the world, contributing 29 per cent to the global jewellery consumption. The sector is home to more than 300,000 gems and jewellery players. Its market size will grow by US\$ 103.06 billion during 2019-2023.

India's demand for gold reached 690.4 tonnes in 2019. India's gems and jewellery export stood at US\$ 29.01 billion in FY20P. During the same period, India exported US\$ 18.66 billion worth of cut and polished diamonds, thereby contributing 64 per cent of the total gems and jewellery export.

India's import of gems and jewellery stood at US\$ 24.01 billion in FY20P.

India is one of the largest exporters of gems and jewellery and the industry is considered to play a vital role in the Indian economy as it contributes a major chunk to country's foreign reserves. The Goods and Services Tax (GST) will steer India's gold demand going forward.

#### Investments/Developments

The gems and jewellery sector is witnessing changes in consumer preferences due to adoption of western lifestyle. Consumers are demanding new designs and varieties in jewellery, and branded jewellers have managed to fulfil their changing demands better than the unorganised players. Moreover, increase in per capita income has led to an increase in sales of jewellery as jewellery is a status symbol in India.

The cumulative Foreign Direct Investment (FDI) inflow in diamond and gold ornaments in the period April 2000 – March 2020 was US\$ 1.17 billion according to Department for Promotion of Industry and Internal Trade (DPIIT).

Some of the key investments in this industry are listed below:

- In April 2020, majority of the players in the Indian market like Malabar Gold, Tanishq, and Joyalukkas offered jewellery online for Akshay Tritiya.
- Companies such as P C Jewellers, P NG Jewellers and Popley and Sons are planning to introduce a virtual-reality (VR) experience for their customers. The customer will have to wear a VR headset, through which they can select any jewellery, see it from different angles and zoom it to view intricate designs.

#### Government Initiatives

- Indian Government made hallmarking mandatory for Gold Jewellery and Artefacts. A period of one year is provided for implementation i.e. till January 2021.
- As per Union Budget 2019-20, the GST rate was reduced from 18 per cent to 5 per cent (\*5 per cent without Input Tax Credit (ITC)) for services by way of job work in relation to gems and jewellery, leather goods, textiles etc.
- The Bureau of Indian Standards (BIS) has revised the standard on gold hallmarking in India from January 2018. The gold jewellery hallmark will now carry a BIS mark, purity in carat and fitness as well as the unit's identification and the jeweller's identification mark. The move is aimed at ensuring a quality check on gold jewellery.
- The Gem and Jewellery Export Promotion Council (GJEPC) signed a memorandum of understanding (MoU) with Maharashtra Industrial Development Corporation (MIDC) to build India's largest jewellery park in at Ghansoli in Navi-Mumbai on 25 acres land with a capacity to have more than 5000 jewellery units of various sizes ranging from 500-10,000 square feet. The overall investment will be of Rs 13,500 crore (US\$ 2.09 billion).
- Gold Monetisation Scheme enables individuals, trusts and mutual funds to deposit gold with banks and earn interest on the same in return.

#### OPPORTUNITIES AND THREATS

The jewellery sector in the country continues to remain poised for growth on account of its demographics as well as increasing urbanisation and income levels. The demand for jewellery is also expanding beyond the traditional marriage functions to a life style and fashion accessory as well. However, at the same time the traditional demand for jewellery continues to remain strong. The sector is witnessing changes in customer preferences due to adoption of western lifestyle and their demand for new designs and varieties in

jewellery. Further, rising quality awareness of customers has also provided a fillip to the organized retail segment, which is banking on its 'reliability' and 'quality' to compete against the highly fragmented unorganized jewellers.

The Indian middle class is expected to rise to 547 million by 2025 and this rise of young Indian middle class is expected to lead to an increase in demand for gold. There is a huge opportunity in the online sale of jewellery. Although, this channel generally caters to low ticket items only, but as a consequence of disruptions caused by the ongoing pandemic COVID-19 scare, this channel is expected to gain traction and gain popularity with the customers for even higher category jewellery.

Rising global uncertainties in the recent months have led to investors resorting to gold and silver as their preferred asset class for investment. Due to this, prices of such precious metals peaked during the year. On an average, international (monthly) gold prices surged 16% YoY in FY20. The falling interest rate also helped grow investors' preference towards gold and silver.

Challenges for the sector have gravely affected after the outbreak of COVID-19 in China which has taken a shape of pandemic and caused stalled manufacturing and trading activities, cancellation of business events, deferment of committed order positions, reduced demand, elongation of receivables etc. in the sector.

The Company does not perceive any major or predictable threats except that the retail jewellery is already a working capital intensive business and the demand for jewellery is now increasing beyond the traditional wedding jewellery. This increase in demand requires additional investment in inventory. Also though the diamond jewellery has higher margins it also has a much longer cash conversion cycle vis-a-vis gold and all of these factors have only increased the working capital intensity of the jewellery business.

### SEGMENT-WISE OR PRODUCT-WISE PERFORMANCE

In regard to resource allocation and assessment of segment performance focuses, there is mainly one segment and the performance of the Company has been provided in "Discussion on Financial Performance with respect to Operational Performance".

### OUTLOOK

The World Gold Council (WGC) sees gold becoming a strong 'financial asset' in India once the Centre rolls out its proposed comprehensive gold policy this year.

According to the new policy, banks will be allowed to do 'Bullion Banking' (take risk in bullion) and new infrastructure such as spot exchanges would be a reality, ushering in transparency and thereby benefiting consumers and small jewellers in particular, PR Somasundaram, Managing Director-India, WGC, told BusinessLine here.

Bullion banking will enable consumers to do bullion-related transactions with banks with ease. Spot exchange will solve for liquidity in the market.

It may be recalled that a draft policy for promotion of gold as a financial asset has already been circulated to relevant Ministries for comments, and a proposal to set up a gold exchange is under consideration by the government.

Against the background of the ongoing Covid-19 pandemic and increased economic uncertainty, gold has become a go-to asset for many investors looking to diversify and hedge their portfolios. Over the past few months, gains in silver prices have lagged those of its yellow peer. While gold has soared by almost 18 per cent year-to-date, the white metal has inched higher by a shy 3 per cent. Nonetheless, with the market remaining firmly bullish, many believe that silver is well positioned to eventually surge to fresh highs. The metal had a somewhat good time in 2019, with its price surging more than 15 per cent and many analysts predicting it to have a great year ahead. According to the silver price trend chart, in September 2019, its value reached highs of \$19.50 per ounce and ended the year at \$18 per ounce.

In 2020, however, financial markets were turned upside down. At the beginning of the year, silver saw its price skyrocketing amid the reports of a US airstrike killing a top Iranian general and Iranian missile attacks on US military bases in Iraq. As frightened investors ran to safe-haven assets, the metal hiked past the \$18.83 mark for the first time in almost four months. But once the tensions between the nations de-escalated, the commodity dropped to its previous lows of \$17.81.

Shortly after, the pandemic hit the world, influencing not only the performance of silver but all global markets. Silver prices quickly shed 38 per cent to hit an 11-year low in March as the start of Covid-19 lockdowns saw investors quitting their positions in favour of cash.

Gold had a remarkable performance in the first half of 2020, increasing by 16.8% in US-dollar terms and significantly outperforming all other major asset classes. By the end of June, the LBMA Gold Price PM was trading close to US\$1,770/oz, a level not seen since 2012, and gold prices were reaching record or near-record highs in all other major currencies.

Though equity markets around the world rebounded sharply from their Q1 lows, the high level of uncertainty surrounding the COVID-19 pandemic and the ultra-low interest rate environment supported strong flight-to-quality flows. Like money market and high-quality bond funds, gold benefited from investors' need to reduce risk, with the recognition of gold as a hedge further underscored by the record inflows seen in gold-backed ETFs.

### RISKS AND CONCERNS

As regards to banks their role in supplying to domestic market has already diminished significantly, from 45 per cent of the total supplies for domestic trade in 2017 calendar year, their share in 2018 was only 35 per cent. In volume terms year-on-year it had declined by 40 per cent to 178 tonnes.

The gold metal loan given by banks may also be under threat if refiners start providing a similar product which is known as "unfixed deferred sales" for 90 days at a premium lower than what banks provide. Such competitive pricing is good but at what cost? And who will regulate their functioning? RBI powers are limited currently only to an extent of payment mechanisms post import. Overtime with mushrooming refiners and poor due diligence in sourcing, banks lost at both ends- one banks losing comfort to onboard a refiner as the client and secondly not able to source from domestic market, eventually banks closed their operation in the

country. Although late, the authorities became more cognizant of the situation and started taking corrective measures following which we are again noticing international banks willing to resume business with the country.

### THE RECOURSE ACTION

It is time the contours for operation of the refiners in India is better defined, and the sourcing guidelines are made mandatory in line with OECD's five-step framework at least by creating a guideline that fits Indian refinery, their financing and remittances models need to be reviewed by the RBI as only two out of the sixteen countries from where refiners import are FATF member countries and more importantly avoid a situation where a shutdown of one refiner can create a potential supply squeeze in the market. When one entity controls 25 to 30 per cent of the refining market locally, systemic risks will increase.

### HUMAN RESOURCE

Equipping the Company with an engaged and productive workforce is essential to our success. We look for commitment, skills and innovative approach in people. In assessing capability, we consider technical skills and knowledge that have been acquired through experience and practice, along with mental processing ability, social process skills and their application.

We continue to invest in developing a pipeline of future talent and nurture them. As part of this process, we provide development and training opportunities to our workforce, which motivates and encourages them to grow in their work.

As on March 31, 2020, the Company had 27 permanent employees. The Company has been maintaining cordial and healthy Industrial Relations, which has helped to a great extent in achieving the upper growth.

The revenue from operations is increased from `1,328,341.76 Lakhs to `21,32,721.81 Lakhs as compared to the previous Year. The revenue from operation was increased by 60.55% over the previous year.

The profit before Tax for the current year is `326.08lakhs as against the profit before tax of `64.00 lakhs in the previous year resulted into profit after tax of `239.66Lakhs compared to profit after tax of previous year `45.81 Lakhs.

The conduct of internal audit is oriented towards the review of internal controls and risks in its operations.

M/s. D G M S & CO., Chartered Accountants (FRN: 0112187W), the statutory auditors of the Company has audited the financial statements included in this annual report and has issued an report annexed as an Annexure B of the Audit Report of the Company on our internal control over financial reporting (as defined in section 143 of Companies Act, 2013).

The audit committee reviews reports submitted by the management and audit reports submitted by internal auditors and statutory auditor. Suggestions for improvement are considered and the audit committee follows up on corrective action. We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the financial statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the standalone financial statements of the current period and are therefore the key audit matters. **Note: - 1 Significant accounting policies:**

**1.0 Corporate Information**

**Amrapali Industries Limited** is a Limited Company, incorporated under the provisions of Companies Act, 1956 and having CIN: L91110GJ1988PLC0674. The Company is engaged in the business of different types of activities like entertainment Activities, Bullion Trading and Share trading, etc. The Registered office at Unit No. PO5-02D, 5th Floor Tower A WTC Gift City Gandhinagar, Gujarat - 382355.

**1.1 Basis of preparation of financial statements**

**a. Accounting Convention: -**

The financial statements have been prepared in accordance with Section 133 of Companies Act, 2013, i.e. Indian Accounting Standards ('Ind AS') notified under Companies (Indian Accounting Standards) Rules 2015. The Ind AS Financial Statements are prepared on historical cost convention, except in case of certain financial instruments which are recognized at fair value.

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Part I of Schedule III to the Companies Act, 2013. Based on the nature of products and the time between the acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of current - non-current classification of assets and liabilities.

**b. Compliance with Ind AS**

The financial statements have been prepared in accordance with Ind AS notified under the Companies (Indian Accounting Standards) Rules, 2015.

**c. Use of Estimates and Judgments**

The preparation of the Ind AS financial statements in conformity with the generally accepted accounting principles in India requires management to make estimates and assumptions that affect the reported amount of assets and liabilities as of the Balance Sheet date, reported amount of revenue and expenses for the year and disclosure of contingent liabilities and contingent assets as of the date of Balance Sheet. The estimates and assumptions used in these Ind AS financial statements are based on management's evaluation of the relevant facts and circumstances as of the date of the Ind AS financial statements. The actual amounts may differ from the estimates used in the preparation of the Ind AS financial statements and the difference between actual results and the estimates are recognized in the period in which the results are known/materialize.

**(A) Revenue recognition**

Revenue from contracts with customers is recognized when control of the goods or services are transferred to the customer at an amount that reflects the consideration entitled in exchange for those goods or services. The Company is generally the principal as it typically controls the goods or services before transferring them to the customer.

Generally, control is transferred upon shipment of goods to the customer or when the goods is made available to the customer, provided transfer of title to the customer occurs and the Company has not retained any significant risks of ownership or future obligations with respect to the goods shipped.

Other operating revenues comprise of income from ancillary activities incidental to the operations of the Company and is recognized when the right to receive the income is established as per the terms of the contract. Service income is recognized as and when services are rendered as per the terms of the contract.

**(B) Other income:**

**Interest:** Interest income is calculated on effective interest rate, but recognised on a time proportion basis taking into account the amount outstanding and the rate applicable.

**Dividend:** Dividend income is recognised when the right to receive dividend is established.

**Insurance Claim:** Insurance Claims are recognised when the claims are assessed to be receivable.

**Rental Income:** Rental income from operating leases is accrued based on the terms of the relevant lease.

### **(C) Intangible Assets and Amortization**

Intangible assets are stated at acquisition cost, net of accumulated amortization and accumulated impairment losses, if any. Intangible assets are amortised on a straight line basis over their estimated useful lives. The amortization period and the amortisation method are reviewed at each financial year end. If the expected useful life of the asset is significantly different from previous estimates, the amortisation period is changed accordingly.

Gains or losses arising from the retirement or disposal of an intangible asset are determined as the difference between the net disposal proceeds and the carrying amount of the asset and recognised as income or expense in the Statement of Profit and Loss.

### **(D) Finance Cost**

Borrowing costs include exchange differences arising from foreign currency borrowings to the extent they are regarded as an adjustment to the interest cost. Borrowing costs that are directly attributable to the acquisition or construction of qualifying assets are capitalised as part of the cost of such assets. A qualifying asset is one that necessarily takes substantial period of time to get ready for its intended use.

Interest income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are charged to the Statement of Profit and Loss for the period for which they are incurred.

### **(E) Inventories**

Inventories are stated at cost or net realisable value whichever is lower. Cost is determined on First-In-First-Out basis.

Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

‘Cost’ comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventory to the present location and condition.

Items such as spare parts, stand-by equipment and servicing equipment which is not plant and machinery gets classified as inventory.

### **(F) Foreign Currency Transactions**

#### **i) Functional currency**

The functional currency of the company is the Indian rupee. These financial statements are presented in Indian rupees.

#### **ii) Initial Recognition**

On initial recognition, all foreign currency transactions are recorded by applying to the foreign currency amount the exchange rate between the functional currency and the foreign currency at the date of the transaction.

#### **iii) Subsequent Recognition**

As at the reporting date, non-monetary items which are carried in terms of historical cost denominated in a foreign currency are reported using the exchange rate at the date of the transaction. All non-monetary items which are carried at fair value or other similar valuation denominated in a foreign currency are reported using the exchange rates that existed when the values were determined.

All monetary assets and liabilities in foreign currency are restated at the end of accounting period. Exchange differences on restatement of all other monetary items are recognised in the Statement of Profit and Loss.

Any the subsequent events occurring after the Balance Sheet date up to the date of the approval of the financial statement of the Company by the board of directors on **June 30, 2021** have been considered, disclosed and adjusted, wherever applicable, as per the requirement of Accounting Standards.



## **(G) Income Tax**

Tax expense for the period, comprising current tax and deferred tax, are included in the determination of the net profit or loss for the period.

### **I. Current tax: -**

Current tax is measured at the amount expected to be paid to the tax authorities in accordance with the taxation laws prevailing in the respective jurisdictions.

Current tax assets and current tax liabilities are offset when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle the asset and the liability on a net basis.

### **II. Deferred tax:-**

Deferred tax is recognized using the balance sheet approach. Deferred tax assets and liabilities are recognized for deductible and taxable temporary differences arising between the tax base of assets and liabilities and their carrying amount in financial statements.

Deferred tax asset is recognized to the extent that it is probable that taxable profit will be available against which such deferred tax assets can be realized. The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred income tax asset to be utilized.

## **(H) Segment Information**

Information reported to the Chief Operating Decision Maker (CODM) for the purposes of resource allocation and assessment of segment performance focuses there is mainly one segment.

### **(I) Earnings per share (EPS):**

Basic EPS is calculated by dividing the net profit or loss for the period attributable to equity shareholders by the weighted average number of equity shares outstanding during the period. For the purpose of calculating diluted EPS, the net profit or loss for the period attributable to equity shareholders and the weighted average number of additional equity shares that would have been outstanding are considered assuming the conversion of all dilutive potential equity shares. Earnings considered in ascertaining the EPS is the net profit for the period and any attributable tax thereto for the period.

### **(J) Cashflow:-**

Cash flows are reported using the indirect method, whereby net profit before tax is adjusted for the effects of transactions of a non-cash nature and any deferrals of past or future cash receipts and payments. The cash flows from regular operating, investing and financing activities of the company are segregated.

### **(K) Financial Instruments:**

Financial assets and financial liabilities are recognised when a company becomes a party to the contractual provisions of the instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

## **(L) Provisions and Contingencies**

### **Provisions:**

Provisions are recognised when there is a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and there is a reliable estimate of the amount of the obligation. Provisions are measured at the best estimate of the expenditure

required to settle the present obligation at the Balance sheet date and are discounted to its present value as appropriate.

**Contingent Liabilities:**

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or nonoccurrence of one or more uncertain future events not wholly within the control of the company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle or a reliable estimate of the amount cannot be made, is termed as a contingent liability.

**(M) Global Health Pandemic COVID - 19**
